6 A RESOLUTION APPROVING THE SUPERVISOR OF  
7 ELECTIONS' DETERMINATION TO PROVIDE TWENTY-FOUR  
8 (24) EARLY VOTING SITES FOR THE 2024  
9 PRESIDENTIAL PREFERENCE PRIMARY ELECTION, THE  
10 2024 PRIMARY ELECTION, AND THE 2024 GENERAL  
11 ELECTION AND IDENTIFYING THE LOCATIONS, DATES,  
12 AND TIMES FOR EARLY VOTING; PROVIDING AN  
13 EFFECTIVE DATE.

15 **WHEREAS**, the Supervisor of Elections is tasked by law with  
16 establishing early voting sites; and

17 **WHEREAS**, Supervisor of Elections Jerry Holland recognizes the  
18 importance of early voting, and the locations, times, and  
19 circumstances under which early voting takes place; and

20 **WHEREAS**, as a result of such importance, Supervisor of  
21 Elections Jerry Holland believes that the community will be better  
22 served if the City Council recommends approval of the early voting  
23 locations and are made more aware of the early voting sites through  
24 the legislative process of City Council approval; and

25 **WHEREAS**, the dates for early voting in 2024 for the  
26 Presidential Preference Primary Election will be March 8, 2024 through  
27 March 16, 2024, and the hours of early voting for the 2024  
28 Presidential Preference Primary Election will be Monday through  
29 Sunday from 10:00 a.m. to 6:00 p.m.; and

30 **WHEREAS**, the dates for early voting in 2024 for the Primary  
31 Election will be August 5, 2024 through August 18, 2024, and the

1 hours of early voting for the 2024 Primary Election will be Monday  
2 through Sunday from 10:00 a.m. to 6:00 p.m.; and

3 **WHEREAS,** the dates for early voting in 2024 for the General  
4 Election will be October 21, 2024 through November 3, 2024, and the  
5 hours of early voting for the 2024 General Election will be Monday  
6 through Sunday from 7:00 a.m. to 7:00 p.m.; and

7 **WHEREAS,** the Supervisor of Elections proposes to conduct early  
8 voting for the Presidential Preference Primary Election, the Primary  
9 Election and the General Election at the locations identified below;  
10 now therefore

11 **BE IT RESOLVED** by the Council of the City of Jacksonville:

12 **Section 1. Early Voting Sites Approved.** The City Council  
13 hereby expresses its approval of the Supervisor of Elections'  
14 selection of twenty-four (24) early voting locations for the 2024  
15 Presidential Preference Primary Election, the 2024 Primary Election,
