5 AN ORDINANCE APPROVING, AND AUTHORIZING THE 6 MAYOR, OR HER DESIGNEE, AND CORPORATION 7 SECRETARY TO EXECUTE AND DELIVER, AN AMENDMENT 8 ONE TO ECONOMIC DEVELOPMENT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND SPRINGFIELD MF 9 PARTNERS, LLC TO AUTHORIZE PAYMENT OF THE SECOND 10 AND FINAL TRANCHE OF THE COMPLETION GRANT AT THE 11 EARLIER OF ONE YEAR FROM SUBSTANTIAL COMPLETION 12 THE PROJECT OR AT SIXTY-PERCENT TENANT 13 OF OCCUPANCY, AND TO ELIMINATE THE CLAWBACK OF THE 14 COMPLETION GRANT IN THE EVENT OF THE SALE OF THE 15 PROJECT PARCEL; PROVIDING AN EFFECTIVE DATE. 16

18 WHEREAS, the City and Springfield MF Partners, LLC (the "Company") previously entered into that certain Economic Development 19 20 Agreement dated April 19, 2023, as authorized by Resolution 2022-905-A, (the "Agreement") pursuant to which the City agreed to provide a 21 22 \$5,500,000 REV Grant ("REV Grant"), and a Completion Grant in the aggregate amount of \$2,000,000, payable in two installments (subject 23 24 to a clawback if the project parcel is sold within the first five 25 years after initial disbursement of the Completion Grant), in support of the Company's construction of an approximately 202-unit, market 26 rate apartment, as more particularly described in the Agreement (the 27 "Project"); and 28

WHEREAS, the Agreement is in full force and effect and the Company is anticipated to substantially complete the Project in accordance with the terms and conditions of the Agreement; and

WHEREAS, the Company has requested and the City has agreed to 1 2 amend the Agreement to: (i) authorize payment of the second tranche 3 of the Completion Grant on the earlier of: (x) one year after substantial completion of the Project; or (y) such date that the 4 5 Project is at least sixty percent (60%) occupied with rental tenants; and (ii) to eliminate the requirement that the Company repay a 6 7 percentage of the Completion Grant if the project parcel is sold, 8 leased or otherwise transferred within five years after disbursement of the Completion Grant; now therefore 9

BE IT ORDAINED by the Council of the City of Jacksonville:

Amendment One to Economic Development Agreement Section 1. 11 approved and execution authorized. There is hereby approved, and the 12 Mayor, or her designee, and Corporation Secretary are hereby 13 authorized to execute and deliver, Amendment One to Economic 14 15 Development Agreement between the City of Jacksonville and Springfield MF Partners, LLC, in substantially the form attached 16 hereto as **Exhibit 1** and incorporated herein by this reference 17 ("Amendment One"). Amendment One amends the Agreement by eliminating 18 19 the clawback language relating to the Completion Grant and authorizing the disbursement of the second tranche of the Completion Grant at the 20 21 earlier of one year from the completion date or when the tenant 22 occupancy rate for the Project reaches sixty percent (60%), all as more particularly set forth in Amendment One. 23

Section 2. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
