6 AN ORDINANCE REGARDING VOTING PRECINCTS;
7 APPROVING THE REVISION AND CHANGES OF CERTAIN
8 VOTING PRECINCT BOUNDARIES IN THE CITY OF
9 JACKSONVILLE, DUVAL COUNTY, FLORIDA, IN RESPONSE
10 TO LITIGATION BROUGHT AGAINST THE SUPERVISOR OF
11 ELECTIONS, AS REQUESTED BY THE SUPERVISOR OF
12 ELECTIONS PURSUANT TO SECTIONS 352.101 AND
13 352.102, *ORDINANCE CODE*; PROVIDING FOR COUNTY
14 PRECINCT MAPS AND POLLING PLACES ON FILE AND
15 ONLINE; PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Precinct Boundary Changes and Renumbering of**
19 **Precincts Approved; Authorizing and Directing Supervisor of Elections**
20 **and Council Secretary to Include Precinct Boundary Changes in the**
21 **Files in Their Respective Offices.** At the request of the Supervisor
22 of Elections for Duval County, as a result of a settlement of that
23 certain lawsuit styled Belinda Coenen, et al. v. Duval County
24 Supervisor of Elections, pending in the United States District Court,
25 Middle District of Florida, Case No. 3:23-cv-868-MMH-MCR, and
26 pursuant to Section 352.101, *Ordinance Code*, the Council, acting as
27 the governing body for Duval County, hereby approves the precinct
28 boundary changes and renumbering of precincts in the City of
29 Jacksonville, Duval County, Florida, as reflected in the individual
30 Council District maps attached hereto as **Exhibit 1 (Precinct Boundary**
31 **Changes)**. The Supervisor of Elections and the Council Secretary are

1 hereby authorized and directed to include the Precinct Maps in their
2 files in their respective offices.

3 **Section 2. Polling Place Location Changes Approved;**
4 **Authorizing and Directing Supervisor of Elections and Council**
5 **Secretary to Include Polling Place Locations in the Files in Their**
6 **Respective Offices.** At the request of the Supervisor of Elections
7 for Duval County, as a result of a settlement of that certain lawsuit
8 styled Belinda Coenen, et al. v. Duval County Supervisor of Elections,
9 pending in the United States District Court, Middle District of
10 Florida, Case No. 3:23-cv-868-MMH-MCR, and pursuant to Section
11 352.102, *Ordinance Code*, the Council, acting as the governing body
12 for Duval County, hereby approves the polling place location changes
13 as listed in the attached **Exhibit 2 ("Polling Place Locations")**, to
14 be effective immediately for all special, primary and general
15 elections conducted after passage. The Supervisor of Elections and
16 the Council Secretary are hereby authorized and directed to include
17 these Polling Place Locations in their files in their respective
18 offices.

19 **Section 3. Precinct Boundary Map of Entire County in the**
20 **Files at Supervisor of Elections and Council Secretary Offices.** A
21 precinct boundary map of the entire county, a map of each new
22 precinct, and the locations of all polling place locations are in the
23 files of the Supervisor of Elections and the Council Secretary in
24 their respective offices. A written description of each precinct
25 boundary is in the Supervisor of Elections' file in his office.
