ORDINANCE 2025-72

AN ORDINANCE APPROPRIATING \$200,000 FROM A GENERAL FUND OPERATING DESIGNATED CONTINGENCY ACCOUNT TO THE GENERAL FUND OPERATING SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORG ACCOUNT, TO PROVIDE CITY GRANT FUNDING TO THE JACKSONVILLE FRATERNAL ORDER OF POLICE FOUNDATION, INC. ("FOP FOUNDATION") TO SUPPORT VARIOUS CHARITABLE AND 11 EDUCATIONAL INITIATIVES AS DESCRIBED HEREIN; 12 13 WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD 14 PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 15 16 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH FOP FOUNDATION; WAIVING 17 SUBSECTION 118.301(A)(3)(III) (EXPENDITURE OF APPROPRIATED FUNDS), PART 3 (ADMINISTRATION OF 19 20 CITY GRANTS), CHAPTER 118 (CITY GRANTS), 21 ORDINANCE CODE, TO ALLOW FOP FOUNDATION TO USE PORTION OF THE CITY GRANT FUNDS FOR Δ CONTRIBUTIONS AND DONATIONS TO OTHER GROUPS OR 23 ORGANIZATIONS; APPROVING, AND AUTHORIZING THE 25 MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF 26 THE CITY A GRANT AGREEMENT BETWEEN THE CITY OF 27 JACKSONVILLE AND FOP FOUNDATION; PROVIDING FOR 28 29 OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE 30 DIVISION OF THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

1 2 BE IT ORDAINED by the Council of the City of Jacksonville: 3 Appropriation. For the 2024-2025 fiscal year, Section 1. 4 within the City's budget, there is hereby appropriated the indicated 5 sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b): 6 7 (The account information is attached hereto as **Exhibit 1** and incorporated herein by this reference) 8 9 (a) Appropriated from:

(c) Explanation of Appropriation:

The funding above is an appropriation of \$200,000 from a 14 15 General Fund Operating Designated Contingency account to the General Fund Operating Subsidies and Contributions to 16 Private Org account, to provide a grant to The Jacksonville 17 Fraternal Order of Foundation, 18 Police Inc. ("FOP Foundation") to support various charitable and educational 19 20 initiatives of the FOP Foundation as described herein.

21 Section 2. Purpose. The purpose of the appropriation in 22 Section 1 is to provide grant funds from the City of Jacksonville to 23 The Jacksonville Fraternal Order of Police Foundation, Inc. to support various FOP Foundation charitable and educational initiatives as 24 25 described in Exhibit 2, attached hereto and incorporated herein by 26 this reference. The FOP Foundation will use a portion of the City 27 funds for donations through its Fallen Officer Relief Fund to provide 28 immediate financial relief to JSO Police and Correctional Officers 29 who are sick, injured, or killed and/or the Officer's immediate family 30 that is impacted by the illness, injury or loss. In addition, a portion of the City funds will be used to cover costs for additional 31

1 training of JSO Police and Correctional Officers that is not covered 2 by the agency, and for donations to various 501(c)(3) charitable 3 organizations located in Duval County that serve the local community.

Waiver of Section 118.107, Ordinance Code. 4 Section 3. The 5 provisions of Section 118.107 (Nonprofits to receive funding through a competitive evaluated award process), Part 1 (General Provisions), 6 7 Chapter 118 (City Grants), Ordinance Code, are hereby waived to allow for a direct contract with FOP Foundation. This waiver is justified 8 9 because FOP Foundation is a unique, non-profit organization that was 10 established to promote the charitable and educational pursuits of law enforcement officers in the Jacksonville community. These funds will 11 12 support the various programs and initiatives administered by FOP Foundation for the benefit of officers and residents of Duval County. 13

14 Section 4. Waiver of Subsection 118.301(a)(3)(iii), 15 Ordinance Code. The provisions of Subsection 118.301(a)(3)(iii) (Expenditure of appropriated funds), Part 3 (Administration of City 16 17 Grants), Chapter 118 (City Grants), Ordinance Code, are hereby waived to allow FOP Foundation to use a portion of the City grant funds to 18 19 make contributions and donations to other groups or organizations. 20 This waiver is justified because FOP Foundation's mission makes it 21 uniquely situated to act as an intermediary between JSO and local 22 charitable organizations.

Approval and Authorization to Execute. There is 23 Section 5. 24 hereby approved, and the Mayor, or her designee, and the Corporation 25 Secretary are hereby authorized to execute and deliver on behalf of 26 the City, a grant agreement with The Jacksonville Fraternal Order of 27 Police Foundation, Inc., in an amount not-to-exceed \$200,000, subject 28 to the Term Sheet and Budget more particularly described in Exhibit 29 2, for a term commencing on October 1, 2024 through September 30, 2025, and all other contracts and documents, including extensions, 30 renewals and amendments to the agreement, and to otherwise take all 31
