22 **Section 1. Appointment.** The Council hereby confirms the
23 Mayor's appointment of Palecia Crawford-Maddox, a Duval County
24 resident, replacing Leola Williams, as a member of the KingSoutel
25 Crossing Community Redevelopment Agency Advisory Board, as a citizen
26 member that lives within one mile of the CRA boundary representing
27 the general public, pursuant to section 53.202 (Membership;
28 appointment and removal; terms of office), Part 2 (KingSoutel Crossing
29 Community Redevelopment Agency Advisory Board), Chapter 53 (Community
30 Redevelopment Agency Advisory Boards), *Ordinance Code*, for a first
31 full to term expire on December 31, 2025.

2 effective upon signature by the Mayor or upon becoming effective
3 without the Mayor's signature.
