and conditions of that certain Economic Development Agreement by and among the City of Jacksonville (the "City"), the Downtown Investment Authority (the "DIA") and the Company dated October 31, 2019 (the "Agreement"), as previously authorized by Resolution 2019-596-A. The Agreement required the Company to complete the construction of a 300,000 square foot office building and structured parking facility, all as more particularly set forth in the Agreement. The City Closing Fund Grant will not be disbursed until all conditions to disbursement have been satisfied under the Agreement and certain other related agreements by and among the City, the DIA and the Company as authorized by Ordinance 2019-527-E.
