7 AN ORDINANCE APPROVING AND AUTHORIZING THE  
8 MAYOR, OR HER DESIGNEE, AND THE CORPORATION  
9 SECRETARY TO EXECUTE AND DELIVER THAT CERTAIN  
10 FOURTH AMENDED AND RESTATED FUNDING AGREEMENT  
11 BETWEEN THE CITY OF JACKSONVILLE AND THE  
12 JACKSONVILLE TRANSPORTATION AUTHORITY ("JTA")  
13 TO FURTHER EXPAND THE "DOOR-TO-STORE PROGRAM"  
14 APPROVED BY ORDINANCE 2021-46-E, AS EXTENDED AND  
15 EXPANDED BY ORDINANCE 2021-140-E, ORDINANCE  
16 2022-135-E, AND ORDINANCE 2023-760-E (THE  
17 "PROGRAM"), A COMPONENT OF THE FULL-SERVICE  
18 GROCERY STORE IMPROVEMENT PROGRAM ESTABLISHED  
19 UNDER ORDINANCE 2019-812-E; PROVIDING FOR CITY  
20 OVERSIGHT AND PROGRAM ADMINISTRATION BY THE  
21 OFFICE OF ECONOMIC DEVELOPMENT; PROVIDING AN  
22 EFFECTIVE DATE.

24 **BE IT ORDAINED** by the Council of the City of Jacksonville:

25 **Section 1. Approval and authorization for the Amended and**  
26 **Restated Funding Agreement.** There is hereby approved, and the Mayor,  
27 or her designee, and the Corporation Secretary are hereby authorized  
28 to execute and deliver, for and on behalf of the City, that certain  
29 Fourth Amended and Restated Funding Agreement (the "Agreement")  
30 between the City of Jacksonville and the Jacksonville Transportation  
31 Authority, attached hereto as **Exhibit 1** and incorporated herein by

1 this reference. The purpose of the Agreement is to expand the  
2 "Door-To-Store Program", as approved by Ordinance 2021-46-E and  
3 previously extended and expanded by Ordinance 2021-140-E, Ordinance  
4 2022-135-E, and Ordinance 2023-760-E, to allow for the inclusion of  
5 a new full-service grocery store and also permit the City and JTA to  
6 include additional full-service grocery stores within the Northwest  
7 Jacksonville Economic Development Fund boundary area in the future  
8 without Council approval.

9 **Section 2. Oversight Department.** The Office of Economic  
10 Development shall oversee and administer the Program described  
11 herein.

12 **Section 3. Effective Date.** This Ordinance shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
