AN ORDINANCE CLOSING AND ABANDONING AND/OR DISCLAIMING 4 UNOPENED AND UNIMPROVED PORTIONS OF THE OAK STREET, MAPLE STREET, AND CEDAR STREET RIGHTS-OF-WAY, ESTABLISHED IN THE PLAT OF DAHLS ADDITION TO GARDEN CITY, AS RECORDED IN PLAT BOOK 6, PAGE 16 OF THE CURRENT PUBLIC RECORDS OF DUVAL COUNTY, FLORIDA, IN COUNCIL DISTRICT 8, AT THE REQUEST OF BIRD DOG, LLC; PROVIDING FOR APPROVAL SUBJECT TO CONDITIONS; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Closure and Abandonment. Four unopened and unimproved portions of the Oak Street, Maple Street and Cedar Street rights-of-way, established in the Plat of Garden City, as recorded in Plat Book 6, page 16 of the current public records of Duval County, Florida, located in Council District 8, a depiction and description of which is attached hereto as Exhibit 1, and incorporated herein by this reference, are hereby closed and abandoned and/or disclaimed as rights-of-way at the request of Bird Dog, LLC (the "Applicant");

The Applicant paid the right-of-way closure application fee of \$8,364.00 for four (4) closures and this sum has been deposited into the City's General Fund account. This closure request was reviewed and approved by the various city, state, and utility agencies that might have an interest in the right-of-way and there were no objections to the Applicant's request.

Section 2. Purpose. The Applicant has requested the

closure in connection with its development of the Hansen Creek residential community of townhomes or duplexes.

abandonment by the City of its interests in the rights-of-way is subject to Applicant's execution and delivery to the City of a Hold Harmless Covenant, in substantially the same form attached hereto as **Exhibit 2**, incorporated herein by this reference. Accordingly, the closure and abandonment of the right-of-way shall not be recorded in the public records until execution and delivery to the City by the Applicant of the required Hold Harmless Covenant.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
