



NOTICE OF PUBLIC HEARING
NOTICE IS HEREBY GIVEN pursuant to Section 147.01 of the Internal Revenue Code of 1986, as amended, of a public hearing by the Jacksonville Housing Finance Authority (the "Authority") to be held on March 20, 2019, at 1214 N. Hogan Street, 6th Floor, Room 825, Jacksonville, Florida 32202, at 1:15pm, in the court thereof for as possible and the purpose of receiving comments and hearing discussion concerning the issuance by the Authority of its Multifamily Housing Revenue Bonds (the Waves Project) Series 2019 in an aggregate face amount of not to exceed \$17,750,000 (the "Bonds"). The proceeds of the Bonds will be loaned to The Waves of Jacksonville, Ltd. or its permitted successors and assigns (the "Contractor") and used for the purpose of financing all or a portion of the costs related to the construction of scattered site multifamily residential housing facilities for persons or families of low, middle or moderate income located at 1st Ave. S. SE of the intersection of 1st Ave. S. and 8th St. S., 1st Ave. S. NW of intersection of 1st Ave. S. and 9th St. S., 1st Ave. S. NE of the intersection of 1st Ave. S. and 9th St. S., and Ave. S. NE of intersection of 2nd Ave. S. and 6th St. S., 5th Ave. S. NW of intersection of 5th Ave. S. and 6th St. S., 6th Ave. S. NE of intersection of 5th Ave. S. and 6th St. S., 6th Ave. S. SE of the intersection of 5th Ave. S. and 6th St. S., 6th Ave. S. SE of the intersection of 5th Ave. S. and 7th Street S., all to be located in Jacksonville Beach, Duval County, Florida 32250, consisting of approximately 127 units to be commonly known as The Waves (the "Project"). The Waves

of Jacksonville, Ltd. or its affiliate is expected to be the owner and operator of the Project.
All interested persons are invited to attend said hearing and either personally or through their representatives, present oral or written comments and discussion concerning the proposed issuance of the Bonds for the purposes described in the preceding paragraph and the nature and location of the Project. Written comments may be submitted to the Jacksonville Housing Finance Authority, 1214 N. Hogan Street, 6th Floor, Jacksonville, Florida 32202. Should any person desire to appeal any decision made by the Authority at this hearing or by the Council of the City of Jacksonville (the "City") with respect to the approval of the issuance of the Bonds for the purposes described in the preceding paragraph, he or she will need a record of the proceedings, and he or she may need to insure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. Comments made at the hearing are for the consideration of the Authority or the City and will not bind the Authority or the City to any action it may take.
