RESOLUTION 2023-448

A RESOLUTION HONORING AND CONGRATULATING CHIEF ADMINISTRATIVE OFFICER BRIAN HUGHES FOR HIS YEARS OF EFFECTIVE SERVICE TO THE CITY OF JACKSONVILLE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Brian Hughes earned a bachelor's degree in media studies at the Catholic University of America and a master's degree in film at Syracuse University, and served his country as a member of the U.S. Air Force during the Gulf War in the early 1990s; and

WHEREAS, prior to joining the City of Jacksonville workforce, Mr. Hughes started his career in public relations, strategic communication and media production for several firms, including his own media company, and taught film and media production at Syracuse, University of the Pacific, and Ramapo College in New Jersey before transitioning into the world of political consulting and government; and

WHEREAS, in January 2018, Mr. Hughes was appointed as Chief of Staff to Mayor Lenny Curry and in October of that year was named as the Interim CEO for the Downtown Investment Authority (DIA) during the DIA's search for a permanent director. Upon the retirement of former Chief Administrative Officer (CAO) Sam Mousa, Mr. Hughes was appointed as the City's CAO in July of 2019, a position from which he will be departing with the change in mayoral administrations; and

WHEREAS, Mr. Hughes has served the City admirably during his tenure in the Mayor's Office, providing strong leadership and guiding the City through both the usual challenges (hurricane emergencies, solid waste hauler difficulties, negotiations with the Jacksonville

Jaguars) and one of the largest disruptions ever to impact city government in the form of the COVID-19 pandemic and the restrictions and challenges it imposed on the City's workforce. He and his leadership team weathered storms both actual and metaphorical and ensured that Jacksonville's citizens always received the highest quality of city services in a timely and efficient manner; and

WHEREAS, Mr. Hughes will be leaving the CAO position as a mayoral transition takes place and will be seeking exciting new challenges; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. The City Council hereby honors and congratulates Brian Hughes for his hard work and dedication to the City and the citizens of Jacksonville as he steps down from the position of Chief Administrative Officer. The Council offers its thanks for his leadership, cooperation and friendship over the years and extends its best wishes as he undertakes new career opportunities.

Section 2. Effective Date. This Resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
