5 AN ORDINANCE APPROPRIATING \$800,000.00 FROM THE  
6 SOLID WASTE DISPOSAL FUND TO PAY FOR THE  
7 PURCHASE OF RECYCLE CARTS AND FOR NECESSARY  
8 TEMPORARY RESIDENTIAL SOLID WASTE COLLECTIONS IN  
9 FISCAL YEAR 2023-2024, AS INITIATED BY B.T. 24-  
10 076; PROVIDING AN EFFECTIVE DATE.

12 **BE IT ORDAINED** by the Council of the City of Jacksonville:

13 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
14 within the City's budget, there are hereby appropriated the indicated  
15 sum(s) from the account(s) listed in subsection (a) to the account(s)  
16 listed in subsection (b):

23 (c) **Explanation of Appropriation:**

24 The funding above represents an appropriation of funds from  
25 within the Solid Waste Disposal Fund for the purchase of  
26 recycle carts and for necessary temporary labor expenses  
27 related to residential solid waste collections in fiscal  
28 year 2023-2024.

29 **Section 2. Purpose.** The purpose of the appropriation in  
30 Section 1 is to fund the purchase of recycle carts and to pay for  
31 temporary labor for necessary residential solid waste collections in

1 fiscal year 2023-2024. This purchase will be funded by contractual  
2 services savings and is anticipated to provide \$350,000.00 to purchase  
3 recycle carts that are needed in order to clear the backlog of cart  
4 requests in by residents in MyJax, and \$450,000.00 to cover temporary  
5 labor expenses for increased residential solid waste collection costs  
6 the City expects to incur during the remainder of fiscal year 2023-  
7 2024 based upon year to date usage.

8 **Section 3. Effective Date.** This Ordinance shall become  
9 effective upon signature by the Mayor or upon becoming effective  
10 without the Mayor's signature.
