AN ORDINANCE REGARDING THE GRANT AGREEMENT
BETWEEN THE CITY OF JACKSONVILLE AND NORTHSIDE
COMMUNITY INVOLVEMENT, INC. ("NCI") FOR THE
COMMUNITIES WITH RESOURCES WORKING TOGETHER FOR
THE BETTERMENT OF JACKSONVILLE, FLORIDA RE-GRANT
PROGRAM (THE "PROGRAM") ORIGINALLY APPROVED AND
AUTHORIZED BY ORDINANCE 2025-472-E; AMENDING
ORDINANCE 2025-472-E BY AMENDING REVISED EXHIBIT
2 (NCI TERM SHEET AND BUDGET) TO REMOVE THE
REQUIREMENT THAT APPLICANTS FOR RE-GRANTS
THROUGH THE PROGRAM MUST HAVE A PHYSICAL ADDRESS
WITHIN COUNCIL DISTRICT 8; REQUESTING ONE CYCLE
EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on September 23, 2025, the City Council enacted Ordinance 2025-472-E to appropriate \$125,000 to Northside Community Involvement, Inc. ("NCI") for the Communities with Resources Working Together for the Betterment of Jacksonville, Florida Re-Grant Program (the "Program") and authorized execution of a grant agreement with NCI for said Program, subject to the Term Sheet and Budget appended as Revised Exhibit 2 to the enacted legislation; and

WHEREAS, the Term Sheet required that all applicants for re-grants through the Program must have a physical address within Council District 8; and

WHEREAS, the District 8 City Council Member desires to allow organizations located throughout Duval County the opportunity to apply for re-grants through the Program and is requesting the City

1 Council's approval of a revised Term Sheet to effectuate this request;
2 now therefore

3 **BE IT ORDAINED** by the Council of the City of Jacksonville:

4 **Section 1. Amending Ordinance 2025-472-E to Replace Revised**

5 **Exhibit 2 (NCI Term Sheet and Budget) as Authorized Herein.** Ordinance
6 2025-472-E, approving and authorizing execution of a grant agreement
7 between the City of Jacksonville and NCI for the Program, is hereby
8 amended to replace the Term Sheet and Budget appended to said
9 legislation with the Term Sheet and Budget attached hereto as **Exhibit**
10 **1** and incorporated herein by this reference. The Term Sheet and
11 Budget attached hereto have been revised to remove the requirement
12 that applicants for re-grants through the Program must have a physical
13 address within Council District 8 with all other terms and conditions
14 of the Term Sheet and Budget remaining the same.

15 **Section 2. Requesting One Cycle Emergency Passage Pursuant**
16 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
17 legislation is requested. The nature of the emergency is that the
18 District 8 City Council Member would like to ensure NCI is able to
19 proceed with the Program, subject to the revised Term Sheet and Budget
20 authorized herein, prior to the end of the calendar year or as soon
21 thereafter as possible.

22 **Section 3. Effective Date.** This Ordinance shall become
23 effective upon signature by the Mayor or upon becoming effective
24 without the Mayor's signature.
