4 **ORDINANCE 2023-267-E**

5 AN ORDINANCE RESCHEDULING THE LAND USE AND
6 ZONING COMMITTEE MEETING OF TUESDAY, MAY 16,
7 2023, TO WEDNESDAY, MAY 17, 2023; DIRECTING
8 APPROPRIATE NOTIFICATION BY THE CHIEF OF THE
9 LEGISLATIVE SERVICES DIVISION; WAIVING COUNCIL
10 RULE 2.201 (MEETINGS) TO AUTHORIZE THE
11 RESCHEDULING; REQUESTING EMERGENCY PASSAGE UPON
12 INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, Council Rule 2.201 (Meetings) provides for Standing
15 Committee meetings to be held during the first and third weeks of
16 every month (except for the first week in July and the third week in
17 December); and

18 **WHEREAS**, pursuant to Council Rule 2.201 (Meetings), the Council
19 President has set the regular meeting of the Land Use and Zoning
20 Committee for the first and third Tuesdays of each month (except for
21 the first week in July and the third week in December); and

22 **WHEREAS**, the Land Use and Zoning Committee is scheduled to meet
23 on Tuesday, May 16, 2023, which is the date of the 2023 Unitary
24 General Election; now therefore

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Land Use and Zoning Committee Meeting on**
27 **Tuesday, May 16, 2023 Rescheduled.** The Land Use and Zoning Committee
28 meeting scheduled for Tuesday, May 16, 2023 in the Council Chambers
29 is hereby rescheduled to Wednesday, May 17, 2023 at 5:00 p.m. in the
30 Council Chambers. The Land Use and Zoning Committee agenda meeting
31 is also hereby rescheduled to Wednesday, May 17, 2023 at 4:30 p.m.

1 in Council Chambers.

2 **Section 2. Notification.** The Chief of Legislative Services
3 is hereby directed to ensure that all public hearings are advertised
4 and scheduled for Wednesday, May 17, 2023, and to ensure that any
5 other notifications necessary to conduct the Land Use and Zoning
6 Committee meeting and agenda meeting on Wednesday, May 17, 2023, are
7 made.

8 **Section 3. Council Rule 2.201 (Meetings) Waived.** Pursuant
9 to Council Rule 2.201 (Meetings), the Council President has set the
10 regular meetings of the Land Use and Zoning Committee for the first
11 and third Tuesdays of each month (except for the first week in July
12 and the third week in December). Council Rule 2.201 (Meetings) is
13 hereby waived to authorize the rescheduling of the Land Use and Zoning
14 Committee meeting as stated herein.

15 **Section 4. Requesting Emergency Passage Upon Introduction**
16 **Pursuant to Council Rule 4.901.** Emergency passage of this legislation
17 upon introduction is requested. The nature of the emergency is that
18 bills filed on April 5, 2023, and introduced at the City Council
19 meeting on April 11, 2023, will be scheduled for public hearings
20 before the Land Use and Zoning Committee during the third week of
21 May. Emergency passage of this legislation upon introduction ensures
22 City staff has time to prepare and issue revised notices and
23 advertisements for these hearings to provide as much advance notice
24 as possible of the rescheduled Land Use and Zoning Committee meeting
25 to May 17, 2023.

26 **Section 5. Effective Date.** This Ordinance shall
27 become effective upon signature by the Mayor or upon becoming
28 effective without the Mayor's signature.
