12 PARTNERSHIP ("HOME") PROGRAM WITHIN THE HOUSING
13 AND COMMUNITY DEVELOPMENT DIVISION OF THE
14 NEIGHBORHOODS DEPARTMENT, AS INITIATED BY R.C.
15 23-062; PROVIDING FOR AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Approval of Deletion of Position in the CDBG-DR**
19 **Program and Addition of Position in the HOME Program.** There is hereby
20 approved the deletion of a vacant Assistant Program Manager - Disaster
21 Recovery position from the Community Development Block Grant -
22 Disaster Recovery program and the addition of an Affordable Housing
23 Development Assistant Administrator position within the HOME
24 Investment Partnership program within the Housing and Community
25 Development Division of the Neighborhoods Department as more fully
26 described in R.C. 23-062, attached hereto as **Exhibit 1** and
27 incorporated herein by this reference. The resulting addition of the
28 Affordable Housing Assistant Administrator position would better
29 serve the needs of the Housing and Community Development Division and
30 will not impact the General Fund.

31 The Affordable Housing Assistant Administrator will be

1 responsible for planning, creating, organizing, administering, and
2 directing the development of affordable housing projects and
3 community development opportunities. Additionally, this position
4 will manage and develop projects and opportunities with oversight of
5 the associated project contractors and consultants.

6 **Section 2. Effective Date.** This Ordinance shall become
7 effective upon signature by the Mayor or upon becoming effective
8 without the Mayor's signature.
