Section 3. Purpose. The purpose of the appropriation in Section 2 is to transfer funds previously appropriated for the Program pursuant to Ordinance 2024-504-E from an account within the Office of Sports and Entertainment to an account within the Grants and Contract Compliance Division of the Finance Department to allow the Grants and Contract Compliance Division to oversee and administer the grant.";
