## RESOLUTION 2025-787-A

RESOLUTION Α COMMEMORATING THE TEN-YEAR ANNIVERSARY OF THE SINKING OF THE EL CONTAINER SHIP, HONORING THE LIVES LOST AND THE ENDURING IMPACT ON THE JACKSONVILLE COMMUNITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 1, 2015, the American cargo ship, SS El Faro, sank in the Atlantic Ocean near the Bahamas during Hurricane Joaquin, resulting in the tragic loss of all 33 crew members aboard, including 28 Americans and 5 people of Polish Descent; and

WHEREAS, the El Faro had departed from Jacksonville on a voyage to San Juan, Puerto Rico, and was operated by TOTE Maritime, a company based in Jacksonville, making the tragedy especially poignant to the Jacksonville community, including the families, friends, and colleagues of those lost; and

WHEREAS, the sinking of the El Faro led to a comprehensive investigation by the United States Coast Guard and the National Transportation Safety Board, resulting in critical recommendations that have since improved maritime practices, vessel operations, and weather forecasting protocol; and

WHEREAS, in 2016, the City Council of Jacksonville renamed Dames Point Park to the El Faro Memorial at Dames Point Park, which remains a place of remembrance and reflection for the families, maritime workers, and the public; and

WHEREAS, the Council of the City of Jacksonville recognizes the

**BE IT RESOLVED** by the Council of the City of Jacksonville:

Section 1.
