5 AN ORDINANCE APPROVING AND AUTHORIZING THE
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION
7 SECRETARY TO EXECUTE AND DELIVER THAT CERTAIN
8 SPECIFIC OPERATING AGREEMENT FOR DELEGATION OF
9 THE STATE OF FLORIDA DEPARTMENT OF ENVIRONMENTAL
10 PROTECTION (FDEP) DOMESTIC WASTEWATER PROGRAM
11 AUTHORITY BETWEEN FDEP AND THE CITY OF
12 JACKSONVILLE, DUVAL COUNTY (THE "AGREEMENT");
13 PROVIDING FOR OVERSIGHT BY THE OFFICE OF
14 ADMINISTRATIVE SERVICES DEPARTMENT,
15 ENVIRONMENTAL QUALITY DIVISION; PROVIDING AN
16 EFFECTIVE DATE.

18 **BE IT ORDAINED** by the Council of the City of Jacksonville:

19 **Section 1. Approval and Authorization.** There is hereby
20 approved, and the Mayor, or her designee, and the Corporation
21 Secretary are hereby authorized to execute and deliver for and on
22 behalf of the City, that certain Specific Operating Agreement for
23 Delegation of the State Of Florida Department of Environmental
24 Protection (FDEP) Domestic Wastewater Program Authority between the
25 FDEP and the City of Jacksonville, Duval County (the "Agreement"),
26 in substantially the same form as placed **On File** with the Legislative
27 Services Division. The Agreement delineates the respective
28 responsibilities of parties for the permitting of sewage collection
29 and transmission facilities within Duval County in accordance with
30 the provisions of Section 403.182, *Florida Statutes*. The Agreement
31 term commences ninety (90) days after execution of the Agreement by

1 both parties and continues until terminated by either party. This
2 contract represents the continuation of a coordinated effort between
3 the parties to address wastewater at the local level, without
4 duplication of efforts, dating back to June 3, 1982.

5 **Section 2. Oversight.** The Office of Administrative
6 Services Department, Environmental Quality Division shall have
7 oversight of the Agreement described herein.

8 **Section 3. Effective Date.** This Ordinance shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
