

NCSPHS AMENDMENT

The Neighborhoods, Community Services, Public Health and Safety Committee offers the following amendment to File No. 2024-460:

- (1) On **page 1, line 6 and page 2, lines 16, 18, 21 and 24, strike** "\$100,000.00" and **insert** "\$250,000.00";
- (2) On **page 1, line 9, after "\$100,000.00" insert** "AND \$150,000.00 FROM THE GENERAL FUND OPERATING - INTERFUND TRANSFER IN ACCOUNT REPRESENTING RETURNED FUNDING RELATED TO TERMINATION OF THE JACKSONVILLE INTERNATIONAL AIRPORT COMMUNITY REDEVELOPMENT AGENCY PURSUANT TO ORDINANCE 2023-496-E TO PROVIDE \$250,000.00 IN FUNDING";

- (6) On **page 2, line 13, strike** "Exhibit 1" and **insert** "Revised **Exhibit 1**, labeled as "Revised Exhibit 1, Rev B.T. 24-114, September 3, 2024 - NCSPHS"";
- (7) On **page 2, line 23, after "\$100,000.00" insert** "and \$150,000.00 from the General Fund Operating - Interfund Transfer In account representing returned funding related to termination of the Jacksonville International Airport Community Redevelopment Agency pursuant to Ordinance 2023-496-E,";
- (8) On **page 2, line 27, after "grant" insert** "consisting of

\$100,000.00”;

- (9) On **page 2, lines 29-30, strike** “to provide \$100,000.00 in additional funding” and **insert** “and to appropriate \$150,000.00 in funding from termination of the Jacksonville International Airport Community Redevelopment Agency to provide a total of \$250,000.00”;
- (10) On **page 3, lines 2-3, strike** “Increase Maximum Indebtedness of” and **insert** “Execute”;
- (11) On **page 3, line 4, strike** “To the extent that” and **insert** “There is hereby approved, and”;
- (12) On **page 3, line 5, strike** “have been” and **insert** “are hereby”;
- (13) On **page 3, line 7, strike** “\$150,000.00” and **insert** “\$250,000.00”;
- (14) On **page 3, lines 10-11, strike** “Exhibit 2” and **insert** “Revised Exhibit 2, labeled as “Revised Exhibit 2, Rev Term Sheet, September 3, 2024 - NCSPHS””;
- (15) On **page 3, lines 11-13, strike** “(the “Agreement”), this Ordinance authorizes an increase in the maximum indebtedness in the Agreement from \$150,000 to \$250,000.” and **insert** “(the “Agreement”).”;
- (16) On **page 4, line 8, strike** “All grant funds” and **insert** “The LATCF-ARP grant funds”;
- (17) Remove **Exhibit 1** and replace with **Revised Exhibit 1**, attached hereto, which attaches the revised B.T. 24-114, to reflect the revised appropriation amount;
- (18) Remove **Exhibit 2** and replace with **Revised Exhibit 2**, attached hereto, which attaches the revised Term Sheet to include the budget by funding source and to add the contract term date;

(19) On **page 1, line 1**, amend the introductory sentence to add that
the bill was amended as reflected herein.
