## RESOLUTION 2023-476

A RESOLUTION HONORING AND COMMENDING ROBERT PHILLIPS ON MORE THAN THREE DECADES OF DEDICATED SERVICE IN THE DUVAL COUNTY SUPERVISOR OF ELECTIONS OFFICE ON THE OCCASION OF HIS RETIREMENT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Robert Phillips, a Jacksonville native, graduated from Bishop Kenny High School and attended Florida State College at Jacksonville before beginning his career in the information technology field; and

WHEREAS, in 1991, Mr. Phillips was hired by Duval County Supervisor of Elections Tommie Bell and began a long and distinguished career managing Jacksonville's elections. During his tenure he has served under five Supervisors of Elections, in every conceivable capacity within the office; gaining invaluable experience and steadily rising through the ranks of the office; and

WHEREAS, Mr. Phillips currently holds the position of Chief Elections Officer and Deputy Supervisor of Elections and is responsible for overseeing the smooth functioning of all aspects of election operations, from recruiting and training poll workers to locating and leasing polling precincts and early voting sites to ballot layout to election day operations; and

WHEREAS, Mr. Phillips is a Master Florida Certified Election Professional and from Auburn University he obtained a national certification as a Certified Elections and Registration Administrator. He is recognized as an expert election resource for the entire state of Florida with an encyclopedic knowledge of election

laws and procedures and a unique ability to convey that knowledge in an easily understandable way with patience and good humor; and

WHEREAS, Mr. Phillips has been involved in the management of over 100 elections in his 32 years in the Duval County Supervisor of Elections Office, ranging from the ordinary (the vast majority), to an unusual tie vote for a City Council seat in Neptune Beach (settled by 3 stages of random chance events), to the infamous Bush v. Gore presidential election in 2000. Throughout every circumstance, Mr. Phillips performed his duties and represented the Duval County Supervisor of Elections Office with professionalism and unquestioned credibility, giving the voting public every confidence that the city's elections have been run with integrity, efficiency and fairness; and WHEREAS, Mr. Phillips has recently announced his retirement
