ORDINANCE APPROPRIATING \$1,000,000 ΑN FROM GENERAL FUND OPERATING/MISCELLANEOUS GRANTS AND ATDS TOMISCELLANOUS NON-DEPARTMENTAL EXPENDITURES TO PROVIDE THE INITIAL INSTALLMENT THE COMPLETION GRANT TO SPRINGFIELD MF PARTNERS, LLC ("COMPANY"), CONSISTENT WITH THE ECONOMIC DEVELOPMENT AGREEMENT PREVIOUSLY APPROVED BY ORDINANCE 2022-905-E, AS INITIATED BY B.T. 25-086; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Jacksonville ("City") and Springfield MF Partners, LLC ("Company") previously entered into that certain Economic Development Agreement dated April 19, 2023 (as amended, the "EDA"), as authorized by Ordinance 2022-905-E, pursuant to which the City, in part, granted the Company a Completion Grant ("Grant") payable in two installments of \$1,000,000 each, in the up-to amount of \$2,000,000, with the first installment due upon substantial completion of the improvements as set forth in the EDA; and

WHEREAS, the improvements were completed by the Company ahead of schedule and OED is requesting the appropriation of the initial installment of the Grant for which the Company is eligible, consistent with the terms and conditions of the EDA; now therefore
