AN ORDINANCE CREATING A NEW SECTION 106.330
(DIRECT APPROPRIATIONS; MINIMUM THRESHOLD),
SUBPART B (SPECIAL PROVISIONS), PART 3
(APPROPRIATIONS), CHAPTER 106 (BUDGET AND
ACCOUNTING CODE), *ORDINANCE CODE*, TO ESTABLISH
A MINIMUM THRESHOLD AMOUNT OF \$25,000 FOR CITY
FUNDING AWARDED TO A FOR-PROFIT OR NOT-FOR-
PROFIT ORGANIZATION BY DIRECT APPROPRIATION IN
ACCORDANCE WITH THE EXEMPTION FROM COMPETITIVE
SOLICITATION OUTLINED IN SUBSECTION 126.108(G),
ORDINANCE CODE; PROVIDING FOR CODIFICATION
INSTRUCTIONS; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

**Section 1. Creating a New Section 106.330 (Direct
appropriations; minimum threshold), Subpart B (Special Provisions),
Part 3 (Appropriations), Chapter 106 (Budget and Accounting Code),
Ordinance Code.** A new Section 106.330 (Direct appropriations; minimum
threshold), Subpart B (Special Provisions), Part 3 (Appropriations),
Chapter 106 (Budget and Accounting Code), *Ordinance Code*, is hereby
created to read as follows:

SUBPART B. – SPECIAL PROVISIONS

1 **Sec. 106.330. - Direct appropriations; minimum threshold.**

2 City funding awarded to a for-profit or not-for-profit
3 organization through a direct appropriation in accordance with the
4 exemption from competitive solicitation outlined in subsection
5 126.108(g) of this Code shall be in an amount not less than \$25,000.

6 **Section 2. Codification Instructions.** The Codifier and the
7 Office of General Counsel are authorized to make all chapter and
8 division "table of contents" consistent with the changes set forth
9 herein. Such editorial changes and any other changes necessary to
10 make the *Ordinance Code* consistent with the intent of this legislation
11 are approved and directed herein, and the changes to the *Ordinance*
12 *Code* shall be made forthwith and when inconsistencies are discovered.

13 **Section 3. Effective Date.** This Ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
