TERMS AND CONDITIONS FOR A FUNDING AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND THE UNIVERSITY OF NORTH FLORIDA FOR REPAIRS AND UPGRADES TO HODGES STADIUM AND CONSTRUCTION OF GRASS PRACTICE FIELDS AT HODGES STADIUM

## Any substantial change to these Terms and Conditions will require City Council approval.

- The parties desire to enter into a funding agreement pursuant to which the City of Jacksonville (the "City") agrees to provide City funding to the University of North Florida ("UNF") for certain repairs and upgrades to Hodges Stadium and construction of additional grass practice fields at the Hodges Stadium facility as described herein, subject to the terms and conditions outlined herein, in addition to any applicable City grant or other contractual provisions deemed necessary or appropriate by the City's Office of General Counsel (the "Agreement").
- The City's maximum indebtedness under the Agreement shall be an amount not-to-exceed \$6,000,000 as described herein. This amount reflects 50% of the estimated costs for completion of Phase I of multiple facilities enhancements to Hodges Stadium. The total estimated cost of Phase I is \$12,000,000. UNF will provide the matching \$6,000,000 for Phase I. UNF shall provide documentation to the City confirming full project financing has been obtained prior to commencement of the project.
- All funding shall be specifically expended for capital expenses incurred by UNF for repairs of and
  upgrades to Hodges Stadium along with construction of additional grass practice fields on property
  owned by UNF (the "Project"). Documentation shall be provided by UNF verifying the
  expenditures incurred for the Project on a quarterly basis in order to draw down funds against this
  appropriation.
- The City shall have the authority to review and approve all planned improvements ("Scope of Work") for the Project prior to UNF contracting with any entity for any work or services relative to design, permitting or construction of the Project.
- The City shall have the authority to review design and material specification submittals (i.e., 30%, 60%, 90%, 100%) for the Project and shall be consulted on all cost reduction or value engineering proposals.
- The City shall withhold a minimum of 10% retainage on all construction work, pending final completion of the Project.
- UNF shall competitively and publicly solicit all professional and construction work and/or services for the Project in compliance with the City's or State's procurement codes.
- All design and construction services shall be conducted by design professionals and/or construction companies (contractors and/or subcontractors) licensed and certified to conduct business in the State of Florida and the City of Jacksonville
- The City funds shall be used solely for work and/or services for the Project as described above.

- UNF shall be responsible for ensuring all federal, state or local permits, as may be necessary or required are obtained prior to conducting any work.
- The City shall provide funding on a reimbursement basis upon its receipt and review and approval of paid invoices from contractors, or any other vendor, and other documentation of expenses actually incurred for the Project, and inspection of the work by the City on a no more frequent than quarterly basis. City funding will be provided on a pro-rata basis, with the City reimbursing a maximum of 50% of the paid invoices submitted by UNF.
- The City shall be granted a waiver of rental fees for the use of the Project facilities as described above for mutually agreed upon community events as scheduling permits.
- The City shall be granted access to the UNF campus at all reasonable times to inspect the work in progress or the final work product.
- The City's administrative staff and the City Council Auditors office shall have the right to audit payment records and supporting documentation for any and all expenditures related to the Project.
- UNF shall be responsible for all maintenance and operation of the Project.
- In the event UNF fails to substantially complete construction of the Project by September 30, 2027, then the City shall be entitled to repayment of all City funds disbursed for the Project from UNF.
- The Agreement shall contain language identifying the City's contribution as a percentage of the Project. Should the Project result in a cost less than the estimated amount described above, the City shall be reimbursed an amount equal to the City's percentage contribution for the Project.
- The City's Public Works Department shall have oversight of the Agreement described herein.
