4 **ORDINANCE 2024-91**

5 AN ORDINANCE CONFIRMING THE MAYOR'S APPOINTMENT  
6 OF LINDA KING, AS A MEMBER OF THE PUBLIC SERVICE  
7 GRANT COUNCIL, FILLING A SEAT FORMERLY HELD BY  
8 BRAD GOODWIN, PURSUANT TO SECTION 80.102  
9 (COMPOSITION; MEMBER QUALIFICATIONS; TERMS;  
10 ANNUAL TRAINING REQUIREMENT; RESPONSIBILITIES),  
11 CHAPTER 80 (PUBLIC SERVICE GRANT COUNCIL),  
12 *ORDINANCE CODE*, FOR AN INITIAL TERM TO EXPIRE ON  
13 DECEMBER 31, 2025, FOLLOWED BY A FIRST FULL TERM  
14 TO EXPIRE ON DECEMBER 31, 2028; REQUESTING ONE-  
15 CYCLE EMERGENCY PASSAGE; WAIVING COUNCIL RULE  
16 4.1101 (APPEARANCE BEFORE COMMITTEE), *COUNCIL*  
17 *RULES*, AS TO THE REQUIREMENT THAT THE APPOINTEE,  
18 PRIOR TO CONFIRMATION, SHALL APPEAR BEFORE THE  
19 COMMITTEE TO WHICH CONSIDERATION OF THE  
20 APPOINTMENT HAS BEEN REFERRED; PROVIDING AN  
21 EFFECTIVE DATE.

23 **WHEREAS**, the initial grant process for the Public Service Grant  
24 ("PSG") Council requires the attention and input of PSG members and  
25 will begin imminently; and

26 **WHEREAS**, PSG Council members are needed to complete member  
27 training, fill vacancies, appoint PSG officers and begin providing  
28 their expertise to the PSG Council as expeditiously as possible; now  
29 therefore

30 **BE IT ORDAINED** by the Council of the City of Jacksonville:  
31

1           **Section 1.       Appointment.**   The Council hereby confirms the  
2 Mayor's appointment of Linda King, a Duval County resident, to the  
3 Public Service Grant Council, filling a seat formerly held by Brad  
4 Goodwin, pursuant to Section 80.102 (Composition; Member  
5 Qualifications; Terms; Annual Training Requirement;  
6 Responsibilities), Chapter 80 (Public Service Grant Council),  
7 *Ordinance Code*, for an initial term to expire on December 31, 2025,  
8 followed by a first full term to expire on December 31, 2028.

9           **Section 2.       Requesting One Cycle Emergency Passage Pursuant**  
10 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this  
11 legislation is requested. The nature of the emergency is that the  
12 time-sensitive initial grant process begins imminently and appointees  
13 are needed to participate in member training and initial grant  
14 processes.

15           **Section 3.       Waiver of Council Rule 4.1101 (Appearance Before**  
16 **Committee), Council Rules.** Council Rule 4.1101 (Appearance Before  
17 Committee), *Council Rules*, is hereby waived as to the requirement  
18 that the appointee, prior to confirmation, be required to appear  
19 before the committee to which consideration of the appointment has  
20 been referred in order to facilitate the emergency passage of this  
21 ordinance and maximize participation of PSG Council members in the  
22 grant process.

23           **Section 4.       Effective Date.** This Ordinance shall become  
24 effective upon signature by the Mayor or upon becoming effective  
25 without the Mayor's signature.
