8 FOURTH AMENDED AND RESTATED FUNDING AGREEMENT
9 BETWEEN THE CITY OF JACKSONVILLE AND THE
10 JACKSONVILLE TRANSPORTATION AUTHORITY ("JTA")
11 TO FURTHER EXPAND THE "DOOR-TO-STORE PROGRAM"
12 APPROVED BY ORDINANCE 2021-46-E, AS EXTENDED AND
13 EXPANDED BY ORDINANCE 2021-140-E, ORDINANCE
14 2022-135-E, AND ORDINANCE 2023-760-E (THE
15 "PROGRAM"), A COMPONENT OF THE FULL-SERVICE
16 GROCERY STORE IMPROVEMENT PROGRAM ESTABLISHED
17 UNDER ORDINANCE 2019-812-E; PROVIDING FOR CITY
18 OVERSIGHT AND PROGRAM ADMINISTRATION BY THE
19 OFFICE OF ECONOMIC DEVELOPMENT; PROVIDING AN
20 EFFECTIVE DATE.

22 **BE IT ORDAINED** by the Council of the City of Jacksonville:

23 **Section 1. Approval and authorization for the Amended and**
24 **Restated Funding Agreement.** There is hereby approved, and the
25 Mayor, or her designee, and the Corporation Secretary are hereby
26 authorized to execute and deliver, for and on behalf of the City,
27 that certain Fourth Amended and Restated Funding Agreement (the
28 "Agreement") between the City of Jacksonville and the Jacksonville
29 Transportation Authority, attached hereto as **Exhibit 1** and
30 incorporated herein by this reference. The purpose of the Agreement
31 is to expand the "Door-To-Store Program", as approved by Ordinance

1 2021-46-E and previously extended and expanded by Ordinance 2021-140-
2 E, Ordinance 2022-135-E, and Ordinance 2023-760-E, to allow for the
3 inclusion of a new full-service grocery store and also permit the
4 City and JTA to include additional full-service grocery stores within
5 the Northwest Jacksonville Economic Development Fund boundary area
6 in the future without Council approval.

7 **Section 2. Oversight Department.** The Office of Economic
8 Development shall oversee and administer the Program described
9 herein.

10 **Section 3. Effective Date.** This Ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
