4 AN ORDINANCE APPROPRIATING \$750,000 FROM THE
5 TOURIST DEVELOPMENT COUNCIL CONTINGENCY
6 ACCOUNT TO TOURIST DEVELOPMENT COUNCIL
7 OPERATIONS ACCOUNT; PURPOSE; PROVIDING FOR
8 CARRYOVER; REQUESTING ONE CYCLE EMERGENCY
9 PASSAGE; PROVIDING FOR OVERSIGHT BY THE DUVAL
10 COUNTY TOURIST DEVELOPMENT COUNCIL; PROVIDING
11 AN EFFECTIVE DATE.

13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
15 within the City's budget, there are hereby appropriated the
16 indicated sum(s) from the account(s) listed in subsection (a) to
17 the account(s) listed in subsection (b):

24 (c) **Explanation of Appropriation.** This ordinance appropriates
25 \$750,000.00 from Reserves in the Tourist Development
26 Contingency Account to Trust Fund Authorized Expenditures
27 in the Tourist Council Operations Account.

28 **Section 2. Purpose.** The purpose of the appropriation
29 above is to provide additional funding to the Duval County Tourist
30 Development Council ("TDC") for grants awarded pursuant to the

1 Tourist Development Plan set forth in Chapter 666, *Ordinance Code*,
2 and the Tourist Development Council Grant Guidelines approved in
3 Ordinance 2018-472-E, as amended (the "Grant Guidelines").

4 **Section 3. Carryover.** The funds appropriated hereby
5 shall not lapse but shall carryover into fiscal year 2020-2021.

6 **Section 4. Requesting one cycle emergency passage**
7 **pursuant to Council Rules 4.901 Emergency.** One cycle emergency
8 passage of this legislation is requested. The nature of the
9 emergency is the TDC's need for additional funding to award grants
10 pursuant to the Tourist Development Plan and the Grant Guidelines.

11 **Section 5. Oversight.** The TDC shall oversee the grant
12 funding described herein.

13 **Section 6. Effective Date.** This ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
