ORDINANCE 2024-165

AN ORDINANCE APPROVING AN AMENDMENT TO THE FAÇADE RENOVATION GRANT PROGRAM APPROVED AS PART OF THE PUBLIC INVESTMENT POLICY OF THE OFFICE OF ECONOMIC DEVELOPMENT TO PROVIDE THAT GRANT MATCHING DOLLARS WILL NOT BE REQUIRED WHEN A CITY-APPROVED JACKSONVILLE SMALL AND EMERGING BUSINESS ("JSEB") IS RETAINED BY AN ELIGIBLE BUSINESS AND COMPLETES THE FAÇADE RENOVATION WORK AND TO INCREASE THE TOTAL AMOUNT OF CITY FUNDING THAT MAY BE PROVIDED IN LEVEL 1 AND LEVEL 2 AREAS; PROVIDING AN EFFECTIVE DATE.

Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals, and welfare): This legislation encourages the use of Jacksonville Small and Emerging Businesses in conducting various facade and other exterior improvements to businesses receiving grant funding from the City through its Facade Renovation Grant Program by eliminating the grant match requirement for eligible businesses who retain JSEBs to complete the renovation work. This serves the public health, safety and welfare by supporting small businesses to give them more economic opportunity through a program designed to reduce blight in the City.
