AN ORDINANCE APPROPRIATING \$51,111.17, ORIGINALLY APPROPRIATED BY ORDINANCE 2025-504-E, FROM THE CITY COUNCIL IT SYSTEMS SOFTWARE - CITY COUNCIL CHAMBER UPGRADE - COMPUTER EQUIPMENT ACCOUNT (\$30,606.01), DM COMPUTER EQUIPMENT AND SOFTWARE ACCOUNT (\$281.16) AND DM CAPITAL PROFESSIONAL SERVICES ACCOUNT (\$20,224.00) TO THE CCSS COUNCIL STAFF SERVICES - COMPUTER EQUIPMENT ACCOUNT (\$30,606.01), DM COMPUTER EQUIPMENT AND SOFTWARE ACCOUNT (\$281.16) AND DM CAPITAL PROFESSIONAL SERVICES ACCOUNT (\$20,224.00), TO COMPLETE THE BUILD OUT OF THE CITY COUNCIL PRODUCTION STUDIO; PROVIDING FOR OVERSIGHT BY CITY COUNCIL CHIEF OF PUBLIC INFORMATION; REQUESTING ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2025-2026 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above is an appropriation of \$51,111.17, originally appropriated by Ordinance 2025-504-E, from the City Council IT Systems Software - City Council Chamber Upgrade - Computer Equipment account (\$30,606.01), DM Computer Equipment and Software account (\$281.16) and DM Capital Professional Services account (\$20,224.00) to the CCSS Council Staff Services - Computer Equipment account (\$30,606.01), DM Computer Equipment and Software account (\$281.16) and DM Capital Professional Services account (\$20,224.00), to complete the build out of the City Council production studio.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to transfer funds from the City Council IT Systems Software - City Council Chamber Upgrade activity to the CCSS Council Staff Services activity to make the funds readily available for Council staff to complete the build out of the City Council production studio. These funds will also be used to appropriately equip Council staff hired to support the production studio and to create content for Jax+, the City Council broadcast and streaming service.

Section 3. Oversight. The City Council Chief of Public Information shall have oversight of the project described herein.

Section 4. Requesting One Cycle Emergency Passage Pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is that the City Council would like the funds appropriated herein to be available to Council staff prior to the end of the calendar year to ensure a more efficient and timely completion of the production studio build out.

Section 5. Effective Date. This Ordinance shall become
