

NCSPHS AMENDMENT

The Neighborhoods, Community Services, Public Health and Safety Committee offers the following amendment to File No. 2024-476:

- (1) On **page 1, line 10 and page 2, line 12**, after "provide" **insert** "\$110,000 in grant";
- (2) On **page 1, line 13 and page 2, line 15**, after "waterfront" **insert** "and to the Repairs and Maintenance Account to provide \$44,100 for property improvements and signage upgrades in Mayport Village, to be managed by the Office of Economic Development";
- (3) On **page 1, line 19**, after "WATERFRONT;" **insert** "WAIVING CONFLICTING PROVISIONS OF SECTION 118.201 (RELEASE OF APPROPRIATIONS), PART 2 (DISBURSEMENT OF CITY GRANTS), CHAPTER 118 (CITY GRANTS), *ORDINANCE CODE*, TO ALLOW FOR ADVANCE PAYMENTS TO MWP;";
- (4) On **page 2, line 2**, **strike** "Exhibit 1" and **insert** "Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev B.T., July 15, 2024 - NCSPHS"";
- (5) On **page 2, lines 5 and 7**, **strike** "Exhibit 1" and **insert** "Revised Exhibit 1";
- (6) On **page 2, lines 20-23**, **strike** "improvements and maintenance to key properties and signage in Mayport, supporting the Florida Youth Maritime Training Commercial Fisherman Apprenticeship Course, hiring a grant writer, and other operational and administrative expenses of MWP" and **insert** "\$110,000 to be paid in quarterly installments as a grant to MWP to be used to hire a grant writer, and other operational

and administrative expenses of MWP, including but not limited to hiring an executive director, administrative personnel, a finance officer, or any combination thereof. The remaining \$44,100 will be used for property improvements and signage upgrades in Mayport Village, to be managed by the Office of Economic Development”;

- (7) On **page 2, line 29**, after “Inc.,” insert “subject to the terms, conditions and budget outlined in **Exhibit 2**, attached hereto and incorporated herein by this reference,”;
- (8) On **page 2, line 30**, strike “\$154,100” and insert “\$110,000”;
- (9) On **page 3, line 6½**, insert a new Section 5 to read as follows:

“**Section 5. Waiving Conflicting Provisions of Section 118.201 (Release of Appropriations), Ordinance Code.** Subsection 118.201(f) (7) (Release of Appropriations), Part 2 (Disbursement of City Grants), Chapter 118 (City Grants), *Ordinance Code*, is hereby waived to allow the grant funds to be disbursed to MWP in four quarterly installments of \$27,500 rather than on a reimbursement basis. This waiver is justified as it allows MWP to continue its outreach and revitalization efforts in Mayport Village recognizing it does not currently have the finances to support reimbursement-based payments.”;
- (10) Renumber the remaining Sections accordingly;
- (11) Remove **Exhibit 1** and replace with **Revised Exhibit 1**, attached hereto, which attaches the revised B.T. to correct the account information;
- (12) Attach a new **Exhibit 2**, attached hereto, which attaches an FY 2023-2024 City Grant Term Sheet outlining the terms, conditions and budget of the grant;

(13) On **page 1, line 1**, amend the introductory sentence to add that
the bill was amended as reflected herein.
