Shannon Ellers, Office of General Counsel, said that the bill amends Chapter 30, Ordinance Code to add language to allow a report or recommendation to the Council or a committee with a simple majority vote after one deferral by the Planning Commission. The bill also calls for action to be taken by Council, or appropriate committee, in the event the Planning Commission does not issue a report or recommendation in within 63 days from the date of application. CM Gaffney explained that a constituent's application was repeatedly deferred by the Planning Commission due to a lack of 5 votes/quorum requirements.

## AMEND(F)/APPROVE

Trista Carraher, Council Auditor's Office, explained the Finance Committee amendment.

CM Newby spoke about this bill, which is an appropriation of \$200,000 from the Social Justice and Community Investment Committee Contingency to provide funds for the Operation Boost! Program, which will offer job training opportunities for under-served populations facing barriers to employment. James Coleman, Workforce Industrial Training, said that the \$100,000 funding to Workforce Industrial Training will provide cost free training for 50 students to earn nationally recognized industrial credentials and certificates upon completion, class materials and job placement assistance.

Virginia Berg, Director of Government Relations FSCJ, said that the \$100,000 funding to FSCJ will provide scholarships for students with demonstrated financial need, and to create a Student Emergency Assistance Fund available to students with financial need to address demonstrated extenuating circumstances and challenges impeding class attendance (transportation, child care etc.).

- 1. Creates new Code Sec. 120.216 providing for a 2021 Limited Retirement Option
- Age 55 with 10 years of credited service (reduced from age 55 with 20 years)
- Age 60 with 5 years of credited service (reduced from age 65 with 5 years)
- Any age with 20 years of credited service, but less than 30 years of credited service, with a reduced accrual rate of 2% (reduced from 25 years of service at any age)
- 2. Police and Fire Pension Fund, Correctional Officer Retirement Plan, and JEA employees are not eligible for this early retirement window
- 3. Establishes a six month early retirement window from 4/1/21 9/30/21
- 4. Requires written or electronic notice of the retirement election and date of retirement to the Board between 4/1/21 5/31/21
- 5. Employees retiring under this option may not come back under full time employment with the City for one year and may not rejoin the DB plan if ever re-employed by the City 6. Allows employees eligible to retire under this option to convert to the Defined Contribution (DC) plan at the actuarial present value of their DB pension
- 7. Provides for an exception to Code Sec. 106.108(c) which requires the affected pension plan to be at least 90% actuarially funded at the time of approval of legislation affecting pension benefits (approval of this exception requires 2/3 vote of Council)

- Section 9.2(d) In the event the Company fails to be create 10 new jobs at an average wage of \$49,472 by December 31, 2023, the REV grant shall terminate and the Company will repay the City the entire amount of the REV grant that has been previously paid to the Company, if any.
