6 A RESOLUTION CONFIRMING THE REAPPOINTMENT OF  
7 BRIAN CHAPPELL, AS A MEMBER OF THE JACKSONVILLE  
8 POLICE AND FIRE PENSION FUND FINANCIAL  
9 INVESTMENT AND ADVISORY COMMITTEE, PURSUANT TO  
10 SECTION 121.503 (FINANCIAL INVESTMENT AND  
11 ADVISORY COMMITTEE; MEMBERSHIP, APPOINTMENT AND  
12 TERMS), PART 5 (FINANCIAL INVESTMENT AND  
13 ADVISORY COMMITTEE), CHAPTER 121 (POLICE AND  
14 FIREFIGHTERS PENSION PLAN), *ORDINANCE CODE*, FOR  
15 A SECOND TERM EXPIRING ON MARCH 1, 2027;  
16 PROVIDING AN EFFECTIVE DATE.

18 **WHEREAS**, Ordinance 2015-304-E enacted June 9, 2015, established  
19 the Financial Investment and Advisory Committee ("Committee") to  
20 provide advice to the Jacksonville Police and Fire Pension Board of  
21 Trustees ("Board") on: (1) financial matters; (2) actuarial practices  
22 and assumptions; (3) investment strategy and policy; (4) the selection  
23 of outside financial services providers, including investment  
24 managers and advisors; and (5) such other matters as requested by the  
25 Board; and

26 **WHEREAS**, Committee members shall be financially sophisticated  
27 professionals with expertise in any or all of the following  
28 competencies: actuarial science, fiscal operations, or investment  
29 practices; which will include knowledge, of and experience and  
30 familiarity with, portfolio and/or pension fund management,  
31 institutional investment and fiduciary responsibilities; and

1           **WHEREAS**, members of the Financial Investment and Advisory  
2 Committee must be residents of Duval, Nassau, St. Johns, Baker or  
3 Clay County, Florida; and

4           **WHEREAS**, the five members of the Committee are nominated by the  
5 Board and are subject to confirmation by the Council; and

6           **WHEREAS**, at its March 22, 2024 meeting, the Board unanimously  
7 nominated Brian Chappell to be reappointed as a member of the  
8 Committee, subject to Council confirmation, as evidenced by Police  
9 and Fire Pension Fund Resolution 2024-03-X-B, a copy of which has  
10 been placed **On File** with the Legislative Services Division; now  
11 therefore

12           **BE IT RESOLVED** by the Council of the City of Jacksonville:

13           **Section 1.       Recitals.** The recitals above are true and  
14 correct and incorporated herein by this reference.

15           **Section 2.       Confirmation.** The Council hereby confirms the  
16 Jacksonville Police and Fire Pension Board of Trustees reappointment  
17 of Brian Chappell, a Duval County resident, to the Financial  
18 Investment and Advisory Committee, in accordance with Section 121.503  
19 (Financial Investment and Advisory Committee; Membership, Appointment  
20 and Terms), Part 5 (Financial Investment and Advisory Committee),  
21 Chapter 121 (Police and Firefighters Pension Plan), *Ordinance Code*,  
22 for a second term expiring on March 1, 2027.

23           **Section 3.       Effective Date.** This resolution shall become  
24 effective upon signature by the Mayor or upon becoming effective  
25 without the Mayor's signature.
