4 **ORDINANCE 2025-107-W**

5 AN ORDINANCE APPROPRIATING \$5,750,000.00 IN SOCIAL
6 IMPACT PARTNERSHIPS TO PAY FOR RESULTS ACT
7 ("SIPPRA") GRANT FUNDS FROM THE U.S. DEPARTMENT OF
8 THE TREASURY ("TREASURY DEPARTMENT"), TO ALLOW THE
9 KIDS HOPE ALLIANCE ("KHA") TO IMPLEMENT A SUITE OF
10 INVESTMENTS INTENDED TO PRODUCE SIGNIFICANT
11 GOVERNMENTAL SAVINGS BY REDUCING NEWBORN EMERGENCY
12 ROOM VISITS AND POSTPARTUM DEPRESSION (THE
13 "PROGRAM"), AS INITIATED BY B.T. 25-044; PURPOSE
14 OF APPROPRIATION; APPROVING A POSITION, AS INITIATED
15 BY R.C. 25-077; INVOKING THE EXCEPTION TO SECTION
16 126.108(G), ORDINANCE CODE, WITH RESPECT TO SERVICES
17 TO BE PROVIDED BY INSTITUTE FOR CHILD SUCCESS AND
18 THE RILEY INSTITUTE; APPROVING, AND AUTHORIZING THE
19 MAYOR, OR HER DESIGNEE, AND THE CORPORATION
20 SECRETARY, AND/OR THE CHIEF EXECUTIVE OFFICER OF
21 KIDS HOPE ALLIANCE, TO EXECUTE AND DELIVER
22 CONTRACTS WITH INSTITUTE FOR CHILD SUCCESS AND THE
23 RILEY INSTITUTE FOR THE PROVISION OF PROFESSIONAL
24 SERVICES FOR THE PROGRAM; WAIVING THE REQUIREMENTS
25 OF SECTION 77.111(A) (PROVIDER CONTRACTS), CHAPTER
26 77 (KIDS HOPE ALLIANCE), *ORDINANCE CODE*, TO EXEMPT
27 THE SERVICES TO BE PROVIDED BY INSTITUTE FOR CHILD
28 SUCCESS AND THE RILEY INSTITUTE FROM COMPETITIVE
29 PROCUREMENT; PROVIDING FOR OVERSIGHT BY KIDS HOPE
30 ALLIANCE; PROVIDING AN EFFECTIVE DATE.

1 BE IT ORDAINED by the Council of the City of Jacksonville:

2 **Section 1. Appropriation.** For the 2024-2025 fiscal year,
3 within the City's budget, there is hereby appropriated the indicated
4 sum(s) from the account(s) listed in subsection (a) to the account(s)
5 listed in subsection (b):

12 (c) Explanation of Appropriation:

13 The funding above represents an appropriation of \$5,750,000
14 in Social Impact Partnerships to Pay for Results Act
15 ("SIPPRA") grant funds from the United State Department of
16 the Treasury ("Treasury Department") to allow the Kids Hope
17 Alliance ("KHA") to launch a suite of investments,
18 including a universal nurse home visit for new parents and
19 a universal early literacy initiative through which health
20 care providers coach parents on reading to their children
21 (the "Program"). These investments will produce
22 significant government savings and value through
23 reductions in newborn emergency room visits and postpartum
24 depression. The grant period begins on December 6, 2024
25 and ends December 31, 2029.

26 **Section 2. Purpose.** The purpose of the appropriation in
27 Section 1 is to provide funding for the Program, and to procure the
28 professional services of Institute for Child Success, as project
29 manager for the Program, and the Riley Institute as the independent
30 evaluator of the Program. This award is subject to the terms and
31 conditions outlined in the United State Department of the Treasury

1 Notice of Award which has been placed **On File** with the Legislative
2 Services Division and is incorporated herein by this reference.

3 **Section 3. Approval of Position.** There is hereby approved
4 the position more fully described in R.C. 25-077, attached hereto as
5 **Exhibit 2** and incorporated herein by this reference. Said position
6 is fully funded by SIPPRA grant dollars and will provide services in
7 support of the Program.

8 **Section 4. Invoking the Exemption in Section 126.108(g),**
9 **Ordinance Code.** KHA is hereby authorized to procure professional
10 services from Institute for Child Success, as Project Manager of the
11 Program, and with the Riley Institute as the Independent Evaluator
12 in compliance with the grant described in Section 2 above. Pursuant
13 to Section 126.108(g) (Exemptions), Part 1 (General Regulations),
14 Chapter 126 (Procurement Code), *Ordinance Code*, such services are
15 exempted from competitive solicitation because the services to be
16 provided are being approved via authorizing legislation pursuant to
17 this Ordinance.

18 **Section 5. Approval and Authorization to Execute.** The
19 Mayor, or her designee, and the Corporation Secretary, and/or the
20 Chief Executive Officer of KHA, are hereby authorized to execute and
21 deliver a contract between KHA and Institute for Child Success, as
22 Project Manager of the Program, and with the Riley Institute as the
23 Independent Evaluator of the Program pursuant to which Institute for
24 Child Success and the Riley Institute will provide professional
25 services necessary for local implementation and administration of the
26 Program in compliance with the grant described in Section 2.

27 **Section 6. Waiver of the Requirements of Chapter 77 (Kids**
28 **Hope Alliance), Section 77.111(a) (Provider Contracts), Ordinance**
29 **Code.** The City hereby waives the requirements of Chapter 77 (Kids
30 Hope Alliance), Section 77.111(a) (Provider Contracts), *Ordinance*
31 *Code*, with respect to the contracts with Institute for Child Success

1 and with the Riley Institute approved and authorized in Section 5 of
2 this Ordinance. Section 77.111(a) requires contracts for children's
3 services provided by third parties to be competitively procured by
4 KHA via an evaluated bid process. This waiver is needed in order to
5 allow KHA to directly contract with Institute for Child Health and
6 the Riley Institute to provide the Program services described in the
7 grant described in Section 2.

8 **Section 7. Oversight Department.** The Kids Hope Alliance
9 shall oversee administration of the grant and the Program.

10 **Section 8. Effective Date.** This Ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
