ORDINANCE 2025-327

AN ORDINANCE APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER A FIRST AMENDMENT TO THEFΥ 2023-2024 CITY GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND UNITED WAY OF NORTHEAST FLORIDA, INC. "AGREEMENT"), TO EXTEND THE TERM OF THE AGREEMENT TO EXPIRE ON JUNE 30, 2025, TO EXTEND CERTAIN OTHER RELATED DATES AND DEADLINES WITHIN THE AGREEMENT, AND TO REVISE THE BUDGET AS DESCRIBED HEREIN; PROVIDING FOR CONTINUED OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance 2023-807-E appropriated \$200,000 to United Way of Northeast Florida, Inc. ("United Way") for the 9-8-8 Crisis Mental Health Call Center Program (the "Program") and authorized the Mayor, or her designee, and the Corporation Secretary to execute, on behalf of the City, a grant agreement between the City and United Way; and

WHEREAS, the term of the FY 2023-2024 City Grant Agreement between the City of Jacksonville and United Way (the "Agreement") dated April 1, 2024, was originally scheduled to expire on March 31, 2025; and

WHEREAS, United Way has requested an extension to the term of the Agreement and further is requesting certain adjustments to the approved Program term sheet and budget to reallocate City funds to line-items that better support the needs of the Program; and

WHEREAS, the City Council therefore desires to extend the term of the Agreement to June 30, 2025 and to amend the Agreement to make the requested adjustments to the approved Program term sheet and budget;

WHEREAS, because these adjustments amount to more than 10% of the affected line-items, City Council approval of the changes is required; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Amendment to Agreement. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver a first amendment to the FY 2023-2024 City Grant Agreement between the City of Jacksonville and United Way of Northeast Florida, Inc. ("United Way") (City Contract #673177-24) (the "Agreement"), to extend the term of the Agreement to June 30, 2025, to extend related dates based on the extension to the term authorized herein, and to replace the current Term Sheet and Budget with the revised Term Sheet and Budget attached hereto as Exhibit 1 and incorporated herein by this reference. The term of the Agreement is hereby ratified and the extension authorized herein will be retroactive to March 31, 2025, to ensure there is no lapse in the contract term.

Section 2. Oversight. The Grants and Contract Compliance Division of the Finance Department shall continue to have oversight of the Agreement described herein.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
