4 **ORDINANCE 2025-327**

5 AN ORDINANCE APPROVING, AND AUTHORIZING THE
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION
7 SECRETARY TO EXECUTE AND DELIVER A FIRST
8 AMENDMENT TO THE FY 2023-2024 CITY GRANT
9 AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND
10 UNITED WAY OF NORTHEAST FLORIDA, INC. (THE
11 "AGREEMENT"), TO EXTEND THE TERM OF THE
12 AGREEMENT TO EXPIRE ON JUNE 30, 2025, TO EXTEND
13 CERTAIN OTHER RELATED DATES AND DEADLINES WITHIN
14 THE AGREEMENT, AND TO REVISE THE BUDGET AS
15 DESCRIBED HEREIN; PROVIDING FOR CONTINUED
16 OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE
17 DIVISION; PROVIDING AN EFFECTIVE DATE.

19 **WHEREAS,** Ordinance 2023-807-E appropriated \$200,000 to United
20 Way of Northeast Florida, Inc. ("United Way") for the 9-8-8 Crisis
21 Mental Health Call Center Program (the "Program") and authorized the
22 Mayor, or her designee, and the Corporation Secretary to execute, on
23 behalf of the City, a grant agreement between the City and United
24 Way; and

25 **WHEREAS,** the term of the FY 2023-2024 City Grant Agreement
26 between the City of Jacksonville and United Way (the "Agreement")
27 dated April 1, 2024, was originally scheduled to expire on March 31,
28 2025; and

29 **WHEREAS,** United Way has requested an extension to the term of
30 the Agreement and further is requesting certain adjustments to the
31 approved Program term sheet and budget to reallocate City funds to

1 line-items that better support the needs of the Program; and

2 **WHEREAS,** the City Council therefore desires to extend the term
3 of the Agreement to June 30, 2025 and to amend the Agreement to make
4 the requested adjustments to the approved Program term sheet and
5 budget;

6 **WHEREAS,** because these adjustments amount to more than 10% of
7 the affected line-items, City Council approval of the changes is
8 required; now therefore

9 **BE IT ORDAINED** by the Council of the City of Jacksonville:

10 **Section 1. Approval and Authorization to Execute an**
11 **Amendment to Agreement.** There is hereby approved, and the Mayor, or
12 her designee, and the Corporation Secretary are hereby authorized to
13 execute and deliver a first amendment to the FY 2023-2024 City Grant
14 Agreement between the City of Jacksonville and United Way of Northeast
15 Florida, Inc. ("United Way") (City Contract #673177-24) (the
16 "Agreement"), to extend the term of the Agreement to June 30, 2025,
17 to extend related dates based on the extension to the term authorized
18 herein, and to replace the current Term Sheet and Budget with the
19 revised Term Sheet and Budget attached hereto as **Exhibit 1** and
20 incorporated herein by this reference. The term of the Agreement is
21 hereby ratified and the extension authorized herein will be
22 retroactive to March 31, 2025, to ensure there is no lapse in the
23 contract term.

24 **Section 2. Oversight.** The Grants and Contract Compliance
25 Division of the Finance Department shall continue to have oversight
26 of the Agreement described herein.

27 **Section 3. Effective Date.** This Ordinance shall become
28 effective upon signature by the Mayor or upon becoming effective
29 without the Mayor's signature.
