RESOLUTION OF THE
JACKSONVILLE ETHICS COMMISSION

WHEREAS, the Jacksonville Ethics Commission is authorized by section 602.921(e), Jacksonville Ordinance Code, to act as the hiring committee, subject to Council confirmation, for the Executive Director of the Ethics, Compliance and Oversight Office; and

WHEREAS, section 602.611, Jacksonville Ordinance Code creates the Office of Ethics, Compliance and Oversight as an independent office administered by the Executive Director to handle citywide ethics training, compliance, and oversight issues; and

WHEREAS, the Jacksonville Ethics Commission believes in the importance of continuity through academic and professional expertise in the City of Jacksonville's ethics standards, procedures, and issues; and

WHEREAS, the Jacksonville Ethics Commission desires to reappoint Kirby Oberdorfer for a second 3-year term as the Director of the Ethics, Compliance and Oversight Office; and


WHEREAS, such action is determined to be in the interest of promoting public trust in government; therefore,

BE IT RESOLVED, by the Jacksonville Ethics Commission as follows:

1. The Jacksonville Ethics Commission hereby reappoints Kirby Oberdorfer to a second three-year term as the Ethics Director for the City of Jacksonville's Office of Ethics, Compliance, and Oversight.
2. The Jacksonville Ethics Commission recommends, pursuant to section 602.612(a)(2), Jacksonville Ordinance Code, that the City Council confirm and approve legislation to appoint Ms. Oberdorfer to a second 3-year term. Office staff are directed to submit the appropriate reappointment legislation to City Council, including a copy of this Resolution, to the Legislative Services Division for filing at the next immediate opportunity following this meeting.
3. This Resolution shall become effective upon its approval by the Jacksonville Ethics Commission on this 17th day of June, 2024.
