5 AN ORDINANCE AMENDING SECTION 82.104 (MEETINGS;
6 COMMITTEES; TASK FORCES), CHAPTER 82
7 (JACKSONVILLE-DUVAL COUNTY COUNCIL ON ELDER
8 AFFAIRS), *ORDINANCE CODE*, TO REDUCE THE NUMBER
9 OF BOARD MEMBERS NECESSARY FOR A QUORUM;
10 PROVIDING FOR CODIFICATION INSTRUCTIONS;
11 PROVIDING AN EFFECTIVE DATE.

13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Amending Section 82.104 (Meetings; committees;**
15 **task forces), *Ordinance Code*.** Section 82.104 (Meetings; committees;
16 task forces), Chapter 82 (Jacksonville-Duval County Council on Elder
17 Affairs), *Ordinance Code*, is hereby amended to read as follows:

18 **CHAPTER 82. - JACKSONVILLE-DUVAL COUNTY COUNCIL ON ELDER AFFAIRS**

20 **Sec. 82.104. - Meetings; committees; task forces; voting and**
21 **quorum.**

23 (d) The Council on Elder Affairs' decisions and recommendations
24 shall require a concurring vote of a majority of the members
25 voting. A majority of the current membership of the Council
26 on Elder Affairs, excluding vacant seats, shall constitute a
27 quorum for the purpose of meetings and transacting business.
28 A vacancy shall not impair the ability of a majority of the
29 remaining members to execute all the duties and perform all
30 the functions of the Council on Elder Affairs.

1 **Section 2. Codification Instructions.** The Codifier and the
2 Office of General Counsel are authorized to make all chapter and
3 division "tables of contents" consistent with the changes set forth
4 herein. Such editorial changes and any others necessary to make the
5 *Ordinance Code* consistent with the intent of this legislation are
6 approved and directed herein, and the changes to the *Ordinance Code*
7 shall be made forthwith and when inconsistencies are discovered.

8 **Section 3. Effective Date.** This Ordinance shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
