Section 2. Purpose. The purpose of the appropriation in Section 1 is to transfer available revenue in the Downtown Northbank CRA Trust Fund from the repayment of an outstanding loan to Florida State College of Jacksonville (the "Loan") to the Downtown Development Loan - Loans Account within Downtown Development Loan Activity in the Downtown Northbank Community Redevelopment Agency (CRA) Trust Fund, which is the Fund and Activity from which the Loan was paid. These funds will be used to fund projects to be approved in the future. A copy of Resolution 2024-06-06 approving this allocation of unappropriated Northbank CRA revenues, unanimously adopted by the Downtown Investment Authority Board on July 1, 2024, is attached hereto as Exhibit 2 and incorporated herein by this reference.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
