8 PREVIOUSLY APPROPRIATED FUNDS FROM THE  
9 FORECLOSURE REGISTRY IN THE AMOUNT OF  
10 \$311,995.85, TO FUND VARIOUS PROGRAMS AND  
11 ACTIVITIES AUTHORIZED PURSUANT TO CHAPTER 179,  
12 *ORDINANCE CODE*, AND THE REMAINDER (\$144,738.81)  
13 FROM ACTIVITY (00001342) TO DISTRIBUTE ACTUAL  
14 BALANCES BETWEEN CURRENT PROJECTS, AS INITIATED  
15 BY B.T. 24-080; AUTHORIZING POSITIONS, AS  
16 INITIATED BY R.C. 24-119; PROVIDING AN EFFECTIVE  
17 DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
21 within the City's budget, there are hereby appropriated the indicated  
22 sum(s) from the account(s) listed in subsection (a) to the account(s)  
23 listed in subsection (b):

31 The funding above comprises \$498,313.88 in revenue

1 collected from the Foreclosure Registry and a reallocation  
2 of previously appropriated funds in the amount of  
3 \$311,995.85 to fund various programs and activities  
4 authorized pursuant to Chapter 179, *Ordinance Code*, and  
5 reallocates \$144,738.81 from Activity (00001342) to  
6 distribute actual balances between current projects.

7 **Section 2. Purpose.** The purpose of the appropriation in  
8 Section 1 is to move revenue actuals and also provide funding for  
9 various programs and activities authorized pursuant to Chapter 179,  
10 *Ordinance Code*. The funds are collected from mortgagees on properties  
11 that are in default.

12 **Section 3. Approval of Positions.** There are hereby  
13 approved the positions more fully described in R.C. 24-119, attached  
14 hereto as **Exhibit 2** and incorporated herein by this reference.

15 **Section 4. Effective Date.** This Ordinance shall become  
16 effective upon signature by the Mayor or upon becoming effective  
17 without the Mayor's signature.
