4 **ORDINANCE 2023-279**

5 AN ORDINANCE AUTHORIZING NAMING OF THE SPORTS
6 PERFORMANCE CENTER AT TIAA BANK FIELD AS "MILLER
7 ELECTRIC CENTER"; PROVIDING AN EFFECTIVE DATE.

9 **WHEREAS**, the City of Jacksonville (the "City") is the owner of
10 that certain facility currently known as "TIAA Bank Field", and the
11 City currently leases TIAA Bank Field to Jacksonville Jaguars, LLC
12 ("JJL"), for its operation of the Jacksonville Jaguars NFL football
13 team and other businesses using the facility pursuant to the terms
14 and conditions set forth in that certain lease between the parties
15 dated September 7, 1993, as amended (the "Lease"); and

16 **WHEREAS**, the City and JJL subsequently entered into that certain
17 Amendment Number 15 to Lease by and between City of Jacksonville and
18 Jacksonville Jaguars, LLC dated September 9, 2021 ("Amendment 15"),
19 pursuant to which the City agreed for JJL to construct on behalf of
20 the City a Sports Performance Center (the "Facility"); and

21 **WHEREAS**, Amendment 15 grants JJL, as operator of the Facility,
22 the right to name the Facility and any portion thereof, subject to
23 the review and approval of the City Council; and

24 **WHEREAS**, JJL has selected Miller Electric as the naming rights
25 sponsor company and proposes the name of "Miller Electric Center" as
26 the name of the Facility; now, therefore

27 **BE IT ORDAINED** by the Council of the City of Jacksonville:

28 **Section 1. Recitals.** The recitals set forth above are true
29 and correct and are incorporated herein by this reference as if fully
30 set forth herein.

31 **Section 2. Sports Performance Center named "Miller Electric**

1 **Center"**. The City Council does hereby consent to and approve Miller
2 Electric as the naming rights sponsor company and the naming of the
3 Sports Performance Center at TIAA Bank Field as "Miller Electric
4 Center", pursuant to and in accordance with Amendment 15. The
5 approval granted herein shall not constitute approval of any
6 subsequent naming or naming rights sponsor company for the Facility
7 and shall lapse upon expiration or termination of the Lease.

8 **Section 3. Effective Date.** This Ordinance shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
