20 **Section 1. Appropriation.** For the 2025-2026 fiscal year,
21 within the City's budget, there are hereby appropriated the indicated

1 The funding above represents an appropriation of \$2,408.74
2 within the General Fund Operating - SERE Registration -
3 Other General Governmental - Miscellaneous Sales and
4 Charges Account, to the General Fund Operating - SERE
5 Registration - Other General Governmental - Food Account,
6 to reimburse funds initially charged to the Employee
7 Training Account, for expenses related to the Florida
8 Certified Election Professionals (FCEP) Session, hosted by
9 the Duval County Supervisor of Elections in October of
10 2025.

11 **Section 2. Purpose.** The purpose of the appropriation in
12 Section 1 is to allocate a reimbursement of funds used in support of
13 the Florida Certified Election Professionals (FCEP) Session, hosted
14 by the Duval County Supervisor of Elections (the "SOE") in October
15 2025. The SOE was responsible for providing breakfast, lunch, snacks,
16 beverages and paper products during the training, and reimbursement
17 for those expenses has been received from the Florida Supervisor of
18 Elections.

19 **Section 3. Effective Date.** This Ordinance shall become
20 effective upon signature by the Mayor or upon becoming effective
21 without the Mayor's signature.
