5 A RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT
6 OF EMILY PIERCE, AS A LAY MEMBER OF THE MOBILITY
7 SYSTEM WORKING GROUP, PURSUANT TO SECTION
8 655.509 (MOBILITY SYSTEM WORKING GROUP), PART 5
9 (MOBILITY SYSTEM), CHAPTER 655 (CONCURRENCY AND
10 MOBILITY MANAGEMENT SYSTEM), *ORDINANCE CODE*, TO
11 SERVE FOR A TERM ENDING WHEN THE CITY COUNCIL
12 TAKES FINAL ACTION ON THE RECOMMENDATIONS OF THE
13 MOBILITY SYSTEM WORKING GROUP; PROVIDING AN
14 EFFECTIVE DATE.

16 **WHEREAS**, Section 655.509, *Ordinance Code*, requires the
17 Planning Department to evaluate the Mobility System and Chapter 655
18 (Concurrency and Mobility Management System) of the Ordinance Code
19 with respect to the Mobility System, within two years following the
20 adoption of the North Florida Transportation Planning Organization's
21 Long Range Transportation Plan ("LRTP"), but at least once every ten
22 years regardless of receipt of the LRTP, and shall update the Mobility
23 System as provided in Section 655.504, *Ordinance Code*; and

24 **WHEREAS**, the Planning Department shall conduct an analysis and
25 present recommendations of appropriate amendments to the Mobility
26 System and Chapter 655 to the Mobility System Working Group, which
27 shall be convened for the purpose of reviewing and approving such
28 recommendations; and

29 **WHEREAS**, the Mobility System Working Group shall be comprised
30 of seven members, with one City Council member appointed by the City
31 Council President, two lay citizens appointed by the City Council

1 President, three lay members appointed by the Mayor, and one lay
2 member appointed jointly by the Mayor and the City Council President;
3 and

4 **WHEREAS,** the Planning Department shall provide the Mayor and
5 the Council with recommendations approved by the Mobility System
6 Working Group (the "Recommendations") for action by the legislative
7 and executive branches of government within 90 days after the
8 approval; and

9 **WHEREAS,** all members of the Mobility System Working Group shall
10 serve until the City Council takes final action on the
11 Recommendations; now therefore

12 **BE IT RESOLVED** by the Council of the City of Jacksonville:

13 **Section 1. Appointment Confirmation.** The Council hereby
14 confirms the Mayor's appointment of Emily Pierce, as a lay member of
15 the Mobility System Working Group, in accordance with Section 655.509
16 (Mobility System Working Group), Part 5 (Mobility System), Chapter
17 655 (Concurrency and Mobility Management System) *Ordinance Code*, to
18 serve for a term ending when the City Council takes final action on
19 the Recommendations.

20 **Section 2. Effective Date.** This Resolution shall become
21 effective upon signature by the Mayor or upon becoming effective
22 without the Mayor's signature.
