1. Call To Order

Chair Gay convened the meeting and called for introductions.

5. Opening Remarks from the Chair

Chair Gay reviewed the JWC charge and processes. He said that public comment will be limited to 2 minutes, and that commissioners would be allotted a reasonable amount of time for debate.

6. OGC Overview of the Sunshine Law

Carla Lopera, OGC, provided an overview of Sunshine and Public Record Laws. She referenced the 3 requirements for public meetings: location accessible to the public, notice of meeting posted at least 24 hours prior, and written minutes of the meeting. Ms. Lopera explained limitations on commissioner communication outside of a public meeting, to include neutral topics like sports and the weather not items that could come before the JWC. She said email communication should be one-way. She talked about penalties for violations. Ms. Lopera talked abut retaining public records, including photographs and text messages. Shannon MacGillis, OGC, mentioned the prohibition on staff acting as a "middle man" to convey information between commissioners, with an exception for logistical planning (time, date of meetings).

7. St. Johns River Status Report on Water Quality & Manatees

Dr. Pinto, Jacksonville University, provided a status report on the St. Johns River. He said that salinity levels are low due to heavy rain. He also said the rain increases the chance for algae blooms. Dr. Pinto talked about a JU webpage in the works to be a platform to report manatee and dolphin sightings. He said there have been no new local manatee deaths since June 16, with 4 total deaths locally this year (one from a watercraft). Statewide this year, Dr. Pinto said that there have been 62 watercraft manatee deaths out of 412 total deaths (the low end of normal). When asked about the health of the river, Dr. Pinto said that the State of the River Report will be out in October, but that overall the river is healthier than it was 30-40 years ago despite population growth.

8. Public Comment

Mr. Nooney spoke about parking enforcement near kayak launches and public access to waterways.

Ms. Shelfer talked about flooding in Ortega.

Public Hearing Pursuant to Ch 166, F.S. & C.R. 3.601 - 8/27/24

There was discussion regarding this bill that is an annual appropriation of \$113,609.00 in Fund Balance from the Environmental Protection Fund that will fund the 17th State of the River Report for the Lower St. Johns River Basin. Dr. Pinto explained the level of collaboration and time that goes into the report each year. Commissioner Devereaux asked about state funds for the report. There was mention of asking neighboring counties to contribute to the cost for the report. Mr. Hoyle said that the funds for the appropriation come from the Environmental Protection Trust Fund, and he emphasized the importance of the report to keep stakeholders and the public informed and to impact policy decisions. Chair Gay concurred as to the importance of the report.

Motion/2nd to approve: Peluso/Amaro Approved unanimously.

There was discussion about adding JEA representatives to an upcoming agenda to speak about the Reed Island Spoil Site and raising power lines.

10. Subcommittee/Task Force Discussion

The commissioners talked about task forces and subcommittees.

Chair Gay said the River Accord Task Force will continue its work with CM Peluso as the chair, with meetings beginning at the end of September.

The Derelict Vessel Task Force will continue, with Commissioner Barker as the chair. Initially Chair Gay said the Shoaling Subcommittee will only meet as needed. The commissioners then decided to incorporate shoaling together with artificial reefs into a blended subcommittee chaired by Commissioner Hardesty.

The FIND Subcommittee will continue with Commissioner Barker as the chair.

Brian Burket, Parks Department, talked about the Maritime Management Plan. He spoke about recent improvements to marina facilities and plans for future land acquisition. When asked he provided an update about the erosion damaged road at Huguenot Memorial Park. He said a temporary road has been constructed to allow the park to reopen, and the City is coordinating with state and federal entities to re-route the roadway.

11. Adjournment

With no further business, Chair Gay adjourned the meeting.
