AN ORDINANCE APPROPRIATING \$100,000 FROM THE
GENERAL FUND OPERATING - CIP DEBT SERVICE
REPAYMENT - ISA-MANAGEMENT FUND - INTEREST
ACCOUNT TO THE GENERAL CAPITAL PROJECTS -
COUNCIL DISTRICT 05 - OTHER CONSTRUCTION COSTS
ACCOUNT TO PROVIDE ADDITIONAL FUNDS FOR TRAFFIC
CALMING AND/OR TRAFFIC SAFETY IMPROVEMENTS IN
COUNCIL DISTRICT 5 IN ACCORDANCE WITH THE
PROVISIONS OUTLINED IN SECTION 11.13 OF
ORDINANCE 2023-504-E AND THE APPLICABLE
PROVISIONS OF SECTION 106.315 (DISTRICT COUNCIL
EXPENDITURES), *ORDINANCE CODE*; PROVIDING AN
EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2025-2026 fiscal year,
within the City's budget, there is hereby appropriated the indicated

5 traffic calming and/or traffic safety improvements in
6 Council District 5.

7 **Section 2. Purpose.** The purpose of the appropriation in
8 Section 1 is to provide additional funds for traffic calming and/or
9 traffic safety improvements in Council District 5 in accordance with
10 the provisions outlined in Section 11.13 of Ordinance 2023-504-E.
11 Expenditures made pursuant to this appropriation shall comply with
12 the applicable provisions of Section 106.315 (District Council
13 expenditures), *Ordinance Code*.

14 **Section 3. Effective Date.** This Ordinance shall become
15 effective upon signature by the Mayor or upon becoming effective
16 without the Mayor's signature.
