Ordinance 2024-507-E is hereby further amended by including the revised Grant Application Solution project information sheet, attached hereto as **Exhibit 3** and incorporated herein by this reference, as part of Exhibit 2 to Ordinance 2024-507-E.";

- (7) Renumber the remaining Section accordingly;
- (8) Remove **Exhibit 1** and replace with **Revised Exhibit 1**, attached hereto, which attaches the revised B.T. to correct account information;
- (9) Attach a new **Exhibit 2**, attached hereto, which attaches the revised Fiscal Year 2025-2029 IT System Development Projects schedule to reflect a reduction in funding for the Grant Application Solution project;
