4 **RESOLUTION 2025-406**

5 A RESOLUTION DECLARING THE MONTH OF JUNE 2025 TO  
6 BE CARIBBEAN AMERICAN HERITAGE MONTH IN  
7 JACKSONVILLE; PROVIDING AN EFFECTIVE DATE.  
8

9 **WHEREAS,** in June 2005, the U.S. House of Representatives  
10 unanimously adopted House Concurrent Resolution 71 recognizing the  
11 significance of Caribbean people and their descendants in the history  
12 and culture of the United States. On February 14, 2006, the resolution  
13 similarly passed the U.S. Senate, and President George W. Bush issued  
14 a Proclamation on June 6, 2006, declaring June to be Caribbean-  
15 American Heritage Month in the United States; and

16 **WHEREAS,** during Caribbean American Heritage Month, we  
17 celebrate the achievements and dreams of the millions of people of  
18 Caribbean origin now living in the United States while honoring the  
19 shared history of joy and perseverance that has united and enriched  
20 life across our region for centuries; and

21 **WHEREAS,** there is no single Caribbean American identity, as  
22 the mix of vibrant cultures, languages, and religions across the  
23 United States and the islands reflects the diversity of spirit that  
24 defines the American story; and

25 **WHEREAS,** meanwhile, our countries are united by common values  
26 and a shared history, overcoming the yoke of colonialism and creating  
27 new opportunities across borders and generations; and

28 **WHEREAS,** Jacksonville, a city in which 3.5% of the population  
29 claims ancestry from one of the Caribbean countries and in which 2.2%  
30 of foreign-born persons who have become American citizens in our  
31 county came from Caribbean countries, is enlivened by the presence

1 of many citizens of Caribbean descent whose businesses, foods, dress,  
2 music, dance, art, and zest for life make our city a more diverse,  
3 exciting place to live; now therefore

4 **BE IT RESOLVED** by the Council of the City of Jacksonville:

5 **Section 1.** The City Council hereby declares the month of  
6 June 2025 to be Caribbean American Heritage Month in Jacksonville in  
7 conjunction with the observances nationwide and encourages all  
8 citizens to become better acquainted with the histories, cultures,  
9 and achievements of our neighbors to the south and to enjoy all the  
10 enrichment that they have to offer our City.

11 **Section 2. Effective Date.** This Resolution shall become  
12 effective upon signature by the Mayor or upon becoming effective  
13 without the Mayor's signature.
