## RESOLUTION 2024-776

A RESOLUTION EXPRESSING THE CITY COUNCIL'S STRONG SUPPORT AND RECOMMENDATION TO THE FLORIDA LEGISLATURE TO WORK TOWARDS MEDICAID EXPANSION IN FLORIDA; DIRECTING THE LEGISLATIVE SERVICES DIVISION TO TRANSMIT COPIES OF THIS RESOLUTION, ONCE ADOPTED, TO THE DUVAL COUNTY LEGISLATIVE DELEGATION, THE SENATE PRESIDENT, THE SPEAKER OF THE HOUSE, AND THE GOVERNOR OF THE STATE OF FLORIDA; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Duval County residents deserve high-quality health care; however, approximately 112,000 Duval County Residents remain uninsured, with an even larger portion underinsured, highlighting the urgent need for comprehensive health care reform; and

WHEREAS, according to the Florida Health Justice Project, there are 2,600,000 Floridians without health insurance despite important gains made since the implementation of the Affordable Care Act; and

WHEREAS, given the increased demand on healthcare resources in Duval County, along with the economic pressures faced by families and businesses due to healthcare costs, a unified approach to health insurance could not only streamline healthcare delivery but also ensure that every resident has access to necessary medical care without the burden of undue financial strain; and

WHEREAS, many people delay or avoid seeking needed health care due to an inability to pay, leading to a population experiencing greater health-related challenges; and

WHEREAS, in Duval County, health-related challenges are compounded in several health zones already facing shortages of medical professionals and facilities, underscoring the importance of a healthcare system that is both accessible and affordable to prevent further strain on our community's well-being and economic stability; and

WHEREAS, Duval County ranks in the bottom third in Florida at  $46^{\rm th}$  out of 67 Counties for overall health outcomes in the state of Florida; and

WHEREAS, Medicaid expansion has been shown to improve health outcomes by providing timely access to preventive care, reducing the rates of mortality, and lowering the prevalence of chronic conditions; and

WHEREAS, the economic benefits of Medicaid expansion include job creation in the healthcare sector, increased state revenue from federal funding, and a reduction in the financial burden on local governments such as the City of Jacksonville, which currently funds emergency care for uninsured residents; and

WHEREAS, in order to equitably and effectively address health care burdens, the expense of these issues should be carried by the federal and state governments in conjunction with local contributions; therefore, we must urge the United States Congress to expand health insurance coverage to provide comprehensive coverage to every resident of the United States without any cost-sharing; and

WHEREAS, Medicaid expansion would provide critical health insurance coverage for more residents in Duval County, ensuring access to necessary medical care including prescription drugs, hospital, surgical and outpatient services, primary and preventive care, emergency services, reproductive care, dental care, vision care, and long-term care; and

WHEREAS, Medicaid expansion, while providing more coverage to

more residents of Duval County, potentially reduces overall healthcare costs by increasing access to preventive and early treatment services, and would save millions in taxpayer dollars by reducing uncompensated care costs and improving health outcomes and quality of life, thereby enhancing the efficiency of healthcare spending; and

WHEREAS, recent polls show that a majority of Americans support
Medicaid expansion; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Medicaid Expansion. The Jacksonville City Council's Support for the Florida Legislature's efforts to expand healthcare coverage for Floridians, including but not limited to, expansion of Medicaid coverage as a means to ensure that all residents have access to affordable and comprehensive healthcare. The Jacksonville City Council calls upon our State Legislators to work toward Medicaid expansion.

Section 2. Direction to Legislative Services Division. The Legislative Services Division is hereby directed to provide a copy of this Resolution, once adopted, to the Duval County Legislative Delegation, the Senate President, the Speaker of the House, and the Governor of the State of Florida.

Section 3. Effective Date. This Resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
