(c) Explanation of Appropriation:

The funding above represents an appropriation of a \$1,899,272.72 grant from the Department of Homeland Security ("DHS") Division of Federal Emergency Management Agency ("FEMA"), and an appropriations of \$178,600.00 from General Fund Reserve for Federal Programs and \$11,327.28 from the General Fund Balance for the required 10% City match, for the Assistance to Firefighters Grant Program (the "AFG") to enhance the safety of the public and firefighters with respect to fire and fire related hazards.

Purpose. The purpose of the appropriation in 15 Section 2. Section 1 is to enhance and support the City of Jacksonville (the 16 "City") / Jacksonville Fire and Rescue Department's ("JFRD") goal to 17 18 increase the number of certified paramedics. The Grant will fund 19 training for sixty (60) members of JFRD to become Nationally 20 Registered Paramedics. Funding will also be used to increase the 21 number of turnout gear extractors that will be housed at strategically 22 identified fire stations throughout the City. The gear extractors will improve the long-term health of the firefighters by eliminating 23 24 carcinogens from turnout gear, thus decreasing the risk of cancer in 25 firefighters. A copy of the Fiscal Year 2023 Assistance to 26 Firefighters Grant Program Award letter (Award Number EMW-2023-FG-27 01743) is attached hereto as **Exhibit 2** and incorporated herein by 2.8 this reference (the "Grant Award Letter"). The Grant period begins 29 on September 26, 2024, and runs through September 25, 2026.

30 Section 3. Oversight Department. The Jacksonville Fire and 31 Rescue Department, Emergency Preparedness Division, shall oversee the
