6 AN ORDINANCE APPROPRIATING \$65,000.00 FROM
7 KIDS HOPE ALLIANCE PROGRAM FUNDS TO TRANSFER
8 \$29,000.00 TO THE JACKSONVILLE PUBLIC LIBRARY
9 GENERAL FUND FOR ADMINISTRATION OF THE JAX
10 KIDS BOOK CLUB AND \$36,000.00 TO THE BOARD OF
11 LIBRARY TRUSTEES TRUST FUND FOR THE STORY
12 JOURNEYS SUMMER LEARNING PROGRAM, AS INITIATED
13 BY B.T. 21-026; AMENDING CHAPTER 111 (SPECIAL
14 REVENUE AND TRUST ACCOUNTS), PART 8
15 (EDUCATION, LIBRARY AND CHILDREN), SECTION
16 111.880 (JAX KIDS BOOK CLUB EDUCATION SPECIAL
17 REVENUE FUND), *ORDINANCE CODE*, TO AUTHORIZE
18 OVERSIGHT OF THE JAX KIDS BOOK CLUB EDUCATION
19 SPECIAL REVENUE FUND BY THE LIBRARY DIRECTOR
20 AND BOARD OF LIBRARY TRUSTEES IN LIEU OF THE
21 CHIEF EXECUTIVE OFFICER AND BOARD OF THE KIDS
22 HOPE ALLIANCE; PROVIDING FOR CODIFICATION
23 INSTRUCTIONS; PROVIDING AN EFFECTIVE DATE.

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
27 within the City's budget, there is hereby appropriated the
28 indicated sum(s) from the account(s) listed in subsection (a) to
29 the account(s) listed in subsection (b):

31 by this reference)

5 (c) Explanation of Appropriation:

6 The funding above is a transfer of funds from the Kids
7 Hope Alliance Out-of-School Time and Early Learning,
8 Literacy and School Readiness Essential Service
9 Categories program funds in the total amount of
10 \$65,000.00, with \$29,000.00 being transferred to the
11 Jacksonville Public Library General Fund and \$36,000.00
12 being transferred to the Board of Library Trustees Trust
13 Fund for administration of the programs described in this
14 ordinance.

15 **Section 2. Purpose.** The purpose of the appropriation in
16 Section 1 is to transfer from the Kids Hope Alliance Out-of-School
17 Time Programming and Early Learning, Literacy and School Readiness
18 Essential Services Categories program funds in the total amount of
19 \$65,000.00 to the Jacksonville Public Library (the "Library"), with
20 \$29,000.00 being deposited in the Library's General Fund for
21 administration of the Jax Kids Book Club and \$36,000.00 being
22 deposited in the Board of Library Trustees Trust Fund for the
23 Library's Story Journeys Summer Learning Program.

24 **Section 3. Amending Chapter 111 (SPECIAL REVENUE AND**
25 **TRUST ACCOUNTS), Part 8 (Education, Library and Children), Section**
26 **111.880 (Jax Kids Book Club Education Special Revenue Fund),**
27 **Ordinance Code.** Chapter 111, (SPECIAL REVENUE AND TRUST ACCOUNTS),
28 Part 8 (Education, Library and Children), Section 111.880 (Jax Kids
29 Book Club Education Special Revenue Fund), *Ordinance Code*, is
30 hereby amended to read as follows:

31 **Chapter 111 (SPECIAL REVENUE AND TRUST ACCOUNTS)**

2 **Part 8 (Education, Library and Children)**

4 **Sec. 111.880. - Jax Kids Book Club Education Special Revenue Fund.**

6 There is created within the General Trust and Agency Fund a
7 special revenue fund account to be known as the *Jax Kids Book Club*
8 *Education Special Revenue Fund* (the "Fund") into which shall be
9 deposited all gifts, donations, contributions, and gifts of a
10 monetary value made for the purpose of supporting the Jax Kids Book
11 Club to be used to pay vendors for writing, illustrating,
12 designing, editing, printing, and distributing books to children in
13 the Jax Kids Book Club, and promoting the book club through the
14 development of brochures and flyers, website production, and family
15 literary activities. All sums placed into the Fund, which shall
16 include all interest earned or accrued thereon, shall be accounted
17 for in a separate self-appropriating account and shall not lapse at
18 the close of any fiscal year but instead shall carry over to the
19 next fiscal year. The Library Director ~~CEO of the Kids Hope~~
20 ~~Alliance (the "Board")~~, or his or her designee, under the direction
21 of the Board of Library Trustees ("the Board") ~~Directors of the~~
22 ~~Board~~, is authorized and directed to solicit sponsorships and funds
23 for contribution to the Fund. The City of Jacksonville Director of
24 Finance and Administration is authorized and directed to make
25 disbursements of principal and interest from the Fund upon the
26 written request of the Library Director ~~CEO of the Board~~, or
27 designee, subject to the availability of funds in the Fund. Nothing
28 in this Section shall prohibit or otherwise limit any
29 appropriations which may be made by the Council to the Board for
30 use toward attaining its purposes, functions, and goals.
31 Notwithstanding the foregoing, no City funds shall be appropriated

1 to the Fund without prior approval by the City Council.

3 **Section 4. Codification Instructions.** The Codifier and
4 the Office of General Counsel are authorized to make all chapter
5 and division "tables of contents" consistent with the changes set
6 forth herein. Such editorial changes and any others necessary to
7 make the *Ordinance Code* consistent with the intent of this
8 legislation are approved and directed herein, and changes to the
9 *Ordinance Code* shall be made forthwith and when inconsistencies are
10 discovered.

11 **Section 5. Effective Date.** This ordinance shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
