11 INCREASE APPROVED BY 2024-630-E FOR FRATERNAL  
12 ORDER OF POLICE (FOP) UNION EMPLOYEES FOR FISCAL  
13 YEAR 2024-2025, AS INITIATED BY B.T. 25-011;  
14 PURPOSE OF APPROPRIATION; AMENDING 2024-504-E,  
15 THE FY 2024-2025 BUDGET ORDINANCE, TO REPLACE  
16 SCHEDULE B1B IN ORDER TO AUTHORIZE AN INCREASE  
17 BY \$771,098 IN THE LOCAL GRANT MATCH FROM THE  
18 CITY OF JACKSONVILLE FOR THE COMMUNITY ORIENTED  
19 POLICING SERVICES - COPS HIRING PROGRAM GRANT  
20 FROM THE U.S. DEPARTMENT OF JUSTICE / OFFICE OF  
21 COMMUNITY ORIENTED POLICING SERVICES; PROVIDING  
22 AN EFFECTIVE DATE.

24 **BE IT ORDAINED** by the Council of the City of Jacksonville:

25 **Section 1. Appropriation.** For the 2024-2025 fiscal year,  
26 within the City's budget, there are hereby appropriated the indicated  
27 sum(s) from the account(s) listed in subsection (a) to the account(s)  
28 listed in subsection (b):

5 The funding above represents a transfer of \$32,696,664.00  
6 from General Fund Collective Bargaining Contingency and  
7 reducing \$5,808,869.00 from the International Association  
8 Of Fire Fighters/ Fraternal Order of Police Health Trust  
9 account within the Group Health Fund to cover the wage  
10 increase for and Fraternal Order of Police (FOP) union  
11 employees for fiscal year 2024-2025.

12 **Section 2. Purpose.** The purpose of the appropriation in  
13 Section 1 is to provide funding to cover the various line items  
14 outlined in B.T. 25-011 relative to the general wage increase for FOP  
15 union employees effective on October 1, 2024.

16 **Section 3. Amending 2024-504-E, the FY 2024-2025 Budget**  
17 **Ordinance, to replace Schedule B1b.** 2024-504-E, the FY 2024-2025  
18 Budget Ordinance, is hereby amended to replace Schedule B1b, entitled  
19 "Schedule of Continuation Grants / Programs with a City Match," in  
20 order in order to authorize an increase by \$771,098 in the local  
21 grant match from the City of Jacksonville for the Community Oriented  
22 Policing Services - Cops Hiring Program Grant from the U.S. Department  
23 of Justice / Office Of Community Oriented Policing Services. The  
24 Revised Schedule B1b is attached hereto as **Exhibit 2.**

25 **Section 4. Effective Date.** This Ordinance shall become  
26 effective upon signature by the Mayor or upon becoming effective  
27 without the Mayor's signature.
