6 FOR CONSTRUCTION AND DEMOLITION DEBRIS RECYCLING
7 FACILITIES; AMENDING SECTION 380.108 (OPERATION
8 OF SOLID WASTE DISPOSAL OR MANAGEMENT FACILITY),
9 PART 1 (CERTIFICATE OF PUBLIC CONVENIENCE AND
10 NECESSITY), CHAPTER 380 (SOLID WASTE
11 MANAGEMENT), *ORDINANCE CODE*, TO AMEND THE
12 MINIMUM RECYCLING PERCENTAGE REQUIREMENTS FOR
13 CONSTRUCTION AND DEMOLITION DEBRIS RECYCLING
14 FACILITIES; PROVIDING FOR CODIFICATION
15 INSTRUCTIONS; PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Amending Section 380.108 (Operation of solid**
19 **waste disposal or management facility), Part 1 (Certificate of Public**
20 **Convenience and Necessity), Chapter 380 (Solid Waste Management),**
21 ***Ordinance Code*.** Section 380.108 (Operation of solid waste disposal
22 or management facility), Part 1 (Certificate of Public Convenience
23 and Necessity), Chapter 380 (Solid Waste Management), *Ordinance Code*,
24 is hereby amended to read as follows:

25 **CHAPTER 380. SOLID WASTE MANAGEMENT**

26 **PART 1. - CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY**

27 * * *

28 **Sec. 380.108. - Operation of solid waste disposal or management**
29 **facility.**

30 The following regulations apply to the operation of a solid waste
31 disposal or management facility:

* * *

(p) For a solid waste management facility identified as a construction and demolition debris recycling facility, clean debris recycling facility, or yard trash recycling facility, as specifically indicated on their initial, renewal or CON modification application and/or was previously approved by Council as such a facility based on their facility description provided in their application, a minimum recycling percentage shall be required on a semi-annual basis for these facilities. The minimum recycling requirement shall apply to all new, renewal and modification applications received after June 1, 2019, and the minimum recycling requirements shall be as follows for each of the subsequent years after:

Construction and Demolition Debris Recycling Facilities	
2019	80% Minimum Recycling
2020	82% Minimum Recycling
2021	84% Minimum Recycling
2022	85% Minimum Recycling
2023	86% Minimum Recycling
2024 <u>2023</u> and subsequent years	87 <u>51</u> % Minimum Recycling
Yard Trash/ Clean Debris Recycling Facilities	
2019	90% Minimum Recycling
2020	92% Minimum Recycling
2021	94% Minimum Recycling
2022	95% Minimum Recycling

2023	97% Minimum Recycling
2024 and subsequent years	98% Minimum Recycling

Section 2. Oversight. The Solid Waste Division of the Public Works Department shall have oversight over this ordinance.

Section 3. Codification Instructions. The Codifier and the Office of General Counsel are authorized to make all chapter and division "tables of contents" consistent with the changes set forth herein. Such editorial changes and any others necessary to make the *Ordinance Code* consistent with the intent of this legislation are approved and directed herein, and changes to the *Ordinance Code* shall be made forthwith and when inconsistencies are discovered.

Section 4. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
