5 AN ORDINANCE APPROPRIATING \$137,000 FROM THE
6 SPECIAL LAW ENFORCEMENT TRUST FUND (THE "FUND")
7 TO FUND VARIOUS CRIME PREVENTION AND LAW
8 ENFORCEMENT EXPENDITURES AND ACTIVITIES
9 INCLUDING: (1) PROVIDING \$37,000 TO PROCURE TWO
10 UTV VEHICLES FOR THE JACKSONVILLE SHERIFF'S
11 OFFICE ("JSO") PATROL UNITS; (2) PROVIDING
12 \$30,000 TO PROCURE A REAL TIME CRIME CENTER
13 WORKSTATION FOR JSO; (3) TRANSFERRING \$12,500
14 FROM THE FUND TO THE TEEN DRIVER SPECIAL REVENUE
15 FUND IN ACCORDANCE WITH SECTION 111.365,
16 *ORDINANCE CODE*, TO FUND THE TEEN DRIVER
17 CHALLENGE PROGRAM; (4) TRANSFERRING \$12,500 FROM
18 THE FUND TO THE POLICE EXPLORERS TRUST FUND IN
19 ACCORDANCE WITH SECTION 111.340, *ORDINANCE CODE*,
20 TO FUND JSO POLICE EXPLORER POST; (5)
21 TRANSFERRING \$25,000 FROM THE FUND TO THE FIRST
22 COAST CRIME STOPPERS; AND (6) \$20,000 TO BE USED
23 FOR THE HOMEWARD BOUND PROGRAM; PROVIDING AN
24 EFFECTIVE DATE.

26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
28 within the City's budget, there is hereby appropriated the indicated
29 sum(s) from the account(s) listed in subsection (a) to the account(s)
30 listed in subsection (b):

6 (c) Explanation of Appropriation:

7 The funding above represents an appropriation of
8 \$137,000.00 from the Special Law Enforcement Trust Fund
9 (the "Fund") to procure contractual services and equipment
10 and includes transfers of Fund dollars to other City funds
11 for various crime prevention and law enforcement
12 expenditures and activities in accordance with the
13 *Ordinance Code* and Section 932.7055, *Florida Statutes*, as
14 more specifically outlined herein.

15 **Section 2. Purpose.** The purpose of the appropriation in
16 Section 1 is to provide \$37,000 to procure two UTV vehicles for the
17 Jacksonville Sheriff's Office ("JSO") patrol units and to provide
18 \$30,000 to procure a Real Time Crime Center Workstation for JSO. In
19 addition, this appropriation will transfer \$12,500 from the Fund to
20 the Teen Driver Special Revenue Fund for the Teen Driver Challenge
21 Program in accordance with Section 111.365, *Ordinance Code*; transfer
22 \$12,500 from the Fund to the Police Explorers Trust Fund for the JSO
23 Police Explorer Post in accordance with Section 111.340, *Ordinance*
24 *Code*; will transfer \$25,000 to First Coast Crime Stoppers; and
25 transfer \$20,000 to the Homeward Bound Program.

26 **Section 3. Effective Date.** This Ordinance shall become
27 effective upon signature by the Mayor or upon becoming effective
28 without the Mayor's signature.
